Â The notice of the Meeting and proxy statement for the Meeting (the â€œProxy Statementâ€) were filed by the Company with the Securities and Exchange Commission as Exhibit 99.1 and Exhibit 99.2, respectively, to its Report on Form 6-K submitted on August 1, 2024, and are incorporated herein by reference. Â The results of shareholder voting on the proposals set forth in the Proxy Statement were as follows: Â Proposal No. Proposal Resolution 1. To re-appoint PwC Israel as the independent auditor of the Company and to authorize the Board of Directors of the Company to determine their remuneration, until the next annual general meeting of the Companyâ€™s shareholders. Approved 2a. To re-appoint Mr. Moshe Tal as a Class II independent director of the Company for a term of three years that expires at the third annual general meeting of the Companyâ€™s shareholders following such re-election and until he ceases to serve in his office in accordance with the provisions of the Companyâ€™s Amended Articles of Association or any law, whichever is the earlier. Approved 2b. To re-appoint Mr. Shachar Daniel as Class II director of the Company for a term of three years that expires at the third annual general meeting of the Companyâ€™s shareholders following such election and until he ceases to serve in his office in accordance with the provisions of the Companyâ€™s Amended Articles of Association or any law, whichever is the earlier. Approved 3. To approve a grant of Restricted Share Units to Mr. Shachar Daniel, the Companyâ€™s Chief Executive Officer and a director. Approved 4. To approve an annual bonus for Mr. Shachar Daniel, the Companyâ€™s Chief Executive Officer and a director, for overachieving measurable targets in the year 2023.
