NOTES TO UNAUDITED CONDENSED CONSOLIDATED FINANCIAL STATEMENTS

NOTE 1 – THE COMPANY AND BASIS OF PREPARATION.

T. Rowe Price Group, Inc. derives its consolidated revenues and net income primarily from investment advisory services that its subsidiaries provide to individual and institutional investors that invest in a broad range of investment solutions across equity, fixed income, multi-asset, and alternative capabilities. We also provide certain investment advisory clients with related administrative services, including distribution, mutual fund transfer agent, accounting, and shareholder services; participant recordkeeping and transfer agent services for defined contribution retirement plans; brokerage; trust services; and non-discretionary advisory services through model delivery.

The investment solutions are provided in a number of vehicles, including the T. Rowe Price U.S. mutual funds ("U.S. mutual funds"), subadvised funds, separately managed accounts, collective investment trusts, and other T. Rowe Price products. The other T. Rowe Price products include: open-ended investment products offered to investors outside the U.S., products offered through variable annuity life insurance plans in the U.S., affiliated private investment funds and collateralized loan obligations.

Investment advisory revenues depend largely on the total value and composition of assets under our management. Accordingly, fluctuations in financial markets and in the composition of assets under management impact our revenues and results of operations.

BASIS OF PRESENTATION.

These unaudited condensed consolidated financial statements are prepared in accordance with accounting principles generally accepted in the United States. These principles require the use of estimates and reflect all adjustments that are, in the opinion of management, necessary for a fair statement of our results for the interim periods presented. All such adjustments are of a normal recurring nature. Actual results may vary from our estimates.

The unaudited financial information contained in these condensed consolidated financial statements should be read in conjunction with the consolidated financial statements contained in our 2023 Annual Report.

NEWLY ISSUED BUT NOT YET ADOPTED ACCOUNTING GUIDANCE.

In November 2023, the Financial Accounting Standards Board ("FASB") issued Accounting Standards Update ("ASU") No. 2023-07 - *Segment Reporting (Topic 280) - Improvements to Reportable Segment Disclosures*. As required by the guidance, we will adopt the annual disclosures of significant segment expenses that are regularly provided to the chief operating decision maker in our 2024 year-end reporting. Interim segment reporting will become effective under the amendment on January 1, 2025.

In December 2023, the FASB issued Accounting Standards Update No. 2023-09 - *Income Taxes (Topic 740) - Improvements to Income Tax Disclosures*, which requires public entities, on an annual basis, to provide disclosure of specific categories in the rate reconciliation, as well as disclosure of income taxes paid disaggregated by jurisdiction. This amendment is effective for the firm on January 1, 2025. We are currently evaluating the impact of adopting this standard and have not yet determined our transition approach.

We have considered all other newly issued accounting guidance that is applicable to our operations and the preparation of our unaudited condensed consolidated statements, including those we have not yet adopted. We do not believe that any such guidance has or will have a material effect on our financial position or results of operations.

NOTE 2 – INFORMATION ABOUT RECEIVABLES, REVENUES, AND SERVICES.

INVESTMENTS IN AFFILIATED COLLATERALIZED LOAN OBLIGATIONS.

There is debt associated with our long-term investments in affiliated collateralized loan obligations ("CLOs"). This debt is carried at **\$84.3 million** \$77.2 million at **March 31, 2024** June 30, 2024 and \$89.4 million at December 31, 2023, and is reported in accounts payable and accrued expenses in our unaudited condensed consolidated balance sheets. The debt includes outstanding repurchase agreements of **€64.2 million** \$61.1 million (equivalent to **€69.3 million** \$65.5 million at **March 31, 2024** June 30, 2024 and \$72.3 million at December 31, 2023 at the respective EUR spot rates) that are collateralized by the CLO investments. Contingent Consideration

As part of the purchase consideration for our acquisition of OHA in December 2021, there was contingent consideration in the amount of up to \$900 million, payable in cash, that may be due as part of an earnout payment starting in 2025 and ending in 2027 upon satisfying or exceeding certain defined revenue targets. These defined revenue targets will be evaluated on a cumulative basis beginning at the end of 2024, with the ability to extend two additional years if the defined revenue targets are not achieved. About 22% of the earnout is conditioned upon continued service with T. Rowe Price and was excluded from the purchase consideration and deemed compensatory. The fair value of the earnout deemed compensatory is remeasured each reporting period and recognized over the related service period. Item 2. Management's Discussion and Analysis of Financial Condition and Results of Operations.**OVERVIEW.**

Our revenues and net income are derived primarily from investment advisory services provided to individual and institutional investors in a broad range of investment solutions across equity, fixed income, multi-asset, and alternative capabilities. We also provide certain investment advisory clients with related administrative services, including distribution, mutual fund transfer agent, accounting, and shareholder services; participant recordkeeping and transfer agent services for defined contribution retirement plans; brokerage; trust services; and non-discretionary advisory services through model delivery.

Investment advisory revenues depend largely on the total value and composition of assets under our management. Accordingly, fluctuations in financial markets and in the composition of assets under management affect our revenues and results of operations.

We incur significant expenditures to develop new products and services and improve and expand our capabilities and distribution channels in order to attract new investment advisory clients and additional investments from our existing clients. These efforts often involve costs that precede any future revenues that we may recognize from an increase to our assets under management.

The investment management industry has been evolving and industry participants are facing several challenging trends including passive investments taking market share from traditional active strategies; continued downward fee pressure; demand for new investment vehicles to meet client needs; and an ever-changing regulatory landscape. In this regard, we have ample liquidity and resources that allow us to take advantage of attractive growth opportunities. We are investing in key capabilities, including investment professionals, distribution professionals, technologies, and new product offerings in order to provide our clients with strong investment management expertise and service.

MARKET TRENDS.

U.S. stocks produced strong first-quarter gains that lifted several broad indexes were mixed in the second quarter amid strength in large, high-growth companies, especially technology-oriented companies expected to all-time highs. The market was driven benefit from artificial intelligence (AI) developments. Developed Asian markets were widely mixed: Japanese shares mostly positive in dollar terms. Shares in Singapore led the region with a 9% gain, exceeding 11%, while Hong Kong but Japanese stocks dropped almost 12% fell 4%.

Emerging equity markets generally rose but trailed outperformed stocks in developed markets in U.S. dollar terms. In Equities in the emerging Europe, Middle East, and Africa (EMEA) region were mostly positive. Turkish shares advanced rose more than 21%, as investors S&P Global Ratings upgraded its sovereign credit rating. Emerging Asian markets were encouraged that the central bank continued to raise interest rates to fight elevated inflation. In Asia, several widely mixed in dollar terms, but Latin American markets produced gains, but Chinese stocks fell slightly, were mostly negative, as the property market remained in distress. ASSETS UNDER MANAGEMENT⁽¹⁾

Assets under management ended the **first** **second** quarter of 2024 at **\$1,542.2 billion** **\$1,569.1 billion**, an increase of **\$97.7 billion** **\$26.9 billion** from **December 31, 2023** **March 31, 2024**. The increase in assets under management during the **first** **second** quarter of 2024 was driven by market appreciation and income, net of distributions not reinvested, of **\$105.7 billion** **\$30.6 billion**, offset by net cash outflows of **\$8.0 billion** **\$3.7 billion**.

For the six months ended June 30, 2024, the increase in assets under management was driven by market appreciation, net of distributions not reinvested, of **\$136.3 billion**, offset by net cash outflows of **\$11.7 billion**.

Assets under management in our target date retirement products, which are included in the multi-asset totals shown above, were \$452.6 billion at June 30, 2024, \$443.0 billion at March 31, 2024, compared with and \$408.4 billion at December 31, 2023. Net flows into these portfolios were \$6.8 billion \$3.7 billion and \$10.5 billion in the first quarter of 2024. three- and six-month periods ended June 30, 2024.

We also provide strategic investment advice solutions for certain portfolios. These advice solutions, which the vast majority is primarily overseen by our multi-asset division, may include strategic asset allocation, and in certain portfolios, asset selection and/or tactical asset allocation overlays. We also offer advice solutions through retail separately managed accounts and separately managed accounts model delivery. As of March 31, 2024 June 30, 2024, total assets in these solutions were \$537 billion \$549 billion, of which \$525 billion \$534 billion are included in our reported assets under management in the tables above.

We provide participant accounting and plan administration for retirement plans that invest in the firm's U.S. mutual funds, collective investment trusts and funds outside of the firm's complex. As of March 31, 2024 June 30, 2024, our assets under administration were \$266 billion \$273 billion, of which nearly \$156 billion \$157 billion are assets we manage.

Results Overview - Quarter ended March 31, 2024 June 30, 2024

Net revenues consist of investment advisory revenues; administrative, distribution, and servicing fees; and capital allocation-based income. Approximately 90% of our net revenues are related to investment advisory fees. Total net revenues were \$1,750.2 million \$1,733.3 million in the first second quarter of 2024, a 13.8% 7.6% increase compared with \$1,537.6 million \$1,610.2 million in the first second quarter of 2023. The increase was primarily driven by an 11.7% 10.8% increase in investment advisory fee revenue as higher overall markets increased average assets under management by 12.2% and 13.0%, partially offset by a \$30.2 million increase \$38.6 million decrease in capital allocation-based income (change in accrued carried interest interest) earned from investments in certain affiliated funds.

Investment advisory fees are generally earned based on the value and composition of our assets under management, which change based on fluctuations in financial markets and net cash flows. As our average assets under management increase or decrease in a given period, the level of our investment advisory fee revenue for that

same period generally fluctuates in a similar manner. Our annualized effective fee rates can be impacted by market or cash flow related shifts among asset classes, vehicles, and products, including those with tiered-fee structures, along with price changes we make in existing products, and asset level changes in products with tiered-fee structures, products.

Capital allocation-based income will fluctuate quarter-to-quarter to reflect the adjustment to accrued carried interest for the change in value of certain affiliated funds, assuming the funds' underlying investments were realized as of the end of the period, regardless of whether the funds' underlying investments have been realized.

Operating expenses on a U.S. GAAP basis were \$1,163.6 million \$1,168.6 million in the first second quarter of 2024, a 10.5% 8.5% increase over the comparable 2023 period. On a non-GAAP basis, operating expenses were \$1,071.4 million \$1,105.8 million, a 4.8% 7.8% increase over the comparable 2023 period.

In comparison to the first second quarter of 2023, about 45% the increases in U.S. GAAP and non-GAAP operating expenses were primarily driven by higher compensation and related benefits, including the interim bonus accrual, along with higher distribution and servicing costs and advertising and promotion costs. The U.S. GAAP operating expense increase was also impacted by intangible amortization and impairments and the remeasurement of contingent consideration liability.

Operating margin in the second quarter of 2024 was 32.6% on a U.S. GAAP basis, compared to 33.1% earned in the second quarter of 2023. The decrease in our U.S. GAAP operating margin for the second quarter of 2024 compared to the 2023 period was driven by operating expense growth outpacing net revenue growth primarily due to acquisition-related amortization and impairments along with changes in the supplemental savings plan liability.

Diluted earnings per share was \$2.11 for the second quarter of 2024 compared to \$2.06 for the second quarter of 2023. The increase was primarily driven by higher operating income offset slightly by lower non-operating income compared to the 2023 period.

On a non-GAAP basis, diluted earnings per share was \$2.26 for the second quarter of 2024 as compared to \$2.02 for the second quarter of 2023. The increase was primarily due to higher adjusted operating income compared to the 2023 period.

Results Overview - Year-to-Date ended June 30, 2024

Net revenues consist of investment advisory revenues; administrative, distribution, and servicing fees; and capital allocation-based income. Approximately 90% of our net revenues for the six months ended June 30, 2024 are related to investment advisory fees. Total net revenues were \$3,483.5 million in the six months ended June 30, 2024, a 10.7% increase compared with \$3,147.8 million in the 2023 period. The increase was primarily driven by a 11.2% increase in investment advisory fee revenue as average assets under management increased by 12.6%.

Operating expenses were \$2,332.2 million in the six months ended June 30, 2024 compared with \$2,130.1 million in the 2023 period. On a non-GAAP basis, our operating expenses for the six months ended June 30, 2024 increased 6.3% to \$2,177.2 million compared to the 2023 period.

In comparison to the six months ended June 30, 2023, more than a third of the increase in U.S. GAAP operating expenses were driven by the remeasurement of the contingent consideration liability, as the 2023 quarter period reflected a \$49.6 million \$72.8 million reduction in the liability compared to no change in the first quarter of 2024 2024 period. Also contributing to the increase in U.S. GAAP operating expenses and the primary drivers of the increase in non-GAAP operating expenses over the prior year were higher compensation and related benefits, including the interim bonus accrual; salaries and benefits along with higher accrued carried interest related compensation, distribution and servicing costs, and advertising and promotion costs.

Operating margin in the first quarter of 2024 six months ended June 30, 2024 was 33.5% on a U.S. GAAP basis, 33.1%, compared to 31.5% 32.3% earned in the 2023 quarter period. The increase in our U.S. GAAP operating margin for the first quarter of 2024 six months ended June 30, 2024 compared to the 2023 period was primarily driven by net revenue growth outpacing operating expense growth.

Diluted earnings per share was \$2.49 \$4.60 for the first quarter of 2024 as six months ended June 30, 2024 compared to \$1.83 \$3.89 for the first quarter of 2023, six months ended June 30, 2023. The 18.3% increase was primarily driven by higher operating income, higher net investment gains, and a lower effective tax rate, and higher net investment gains in the six months ended June 30, 2024, as compared to the comparable 2023 period period.

Investment advisory fees in the first second quarter of 2024 increased 11.7% 10.8% over the comparable 2023 quarter as average assets under management increased \$161.5 billion \$176.6 billion or 12.2% 13.0%, to \$1,484.4 billion \$1,534.0 billion. For the six months ended June 30, 2024, investment advisory revenues increased 11.2% over the comparable 2023 period as average assets under management increased \$169.0 billion, or 12.6%, to \$1,509.2 billion.

Our investment advisory The average annualized effective fee rate of 42.1 bps earned for the first quarter of 2024 three- and six-month periods ended June 30, 2024 declined compared with 42.7 basis points earned in the comparable 2023 quarter periods due to client flows and 42.2 basis points earned during the fourth quarter of 2023. The increase in the first quarter of 2024 is primarily driven by higher fees related to transfer agent services provided alternative products compared to the T. Rowe Price mutual funds.

Our net revenues reflect the elimination of advisory and administrative fee revenue earned from our consolidated sponsored investment products. The corresponding expenses recognized by these products, and consolidated in our financial statements, were also eliminated from operating expenses. For the first quarter, we eliminated net revenue of \$1.2 million in 2024 and \$0.6 million in 2023. 2023 year-to-date period.

Capital allocation-based income in the first second quarter of 2024 increased net revenues by \$47.1 million. The first quarter of 2024 amount represents \$0.1 million compared to an increase in net revenues of \$59.5 million \$38.7 million in accrued carried interest from investments in affiliated investment funds, partially offset by \$12.4 million in non-cash acquisition-related amortization. 

The increases for both periods were primarily due to higher retail transfer agent servicing activities provided to the T. Rowe Price mutual funds and higher average assets on which we earn administrative revenue for non-discretionary advisory services.

Our net revenues reflect the elimination of advisory and administrative fee revenue earned from our consolidated sponsored investment products. The corresponding expenses recognized by these products, and consolidated in our financial statements, were also eliminated from operating expenses. For the second quarter, we eliminated net revenue of \$0.5 million in 2024 and \$0.3 million in 2023. For the six months ended June 30, we eliminated net revenue of \$1.7 million in 2024 and \$0.9 million in 2023.

Compensation, benefits, and related costs were \$629.3 million \$635.8 million in the first second quarter of 2024, an increase of \$36.0 million \$44.8 million, or 6.1% 7.6%, compared to the 2023 quarter. For the six months ended June 30, 2024, these costs were \$1,265.1 million, an increase of \$80.8 million, or 6.8%, compared to the 2023 period. The increase was in both periods were primarily due to a higher interim bonus accrual, and higher salaries and related benefits, primarily due to as base salary increases modestly increased in January 2024. The increases for both periods were primarily driven by higher media spend and increased investment in our brand.

Technology, occupancy, and facility costs were \$149.9 million \$160.7 million in the first second quarter of 2024, an increase of \$3.3 million \$6.2 million, or 2.3% 4.0%, compared to the \$146.6 million \$154.7 million recognized in the 2023 quarter. For the six months ended June

The rate also experiences volatility from the remeasurement of the contingent consideration liability, as well as changes in deferred tax asset valuation allowances, primarily in foreign jurisdictions, based on the sufficiency of taxable income in future periods. Our U.S. GAAP rate will also be impacted by changes in the proportion of net income that is attributable to our redeemable non-controlling interests and non-controlling interests reflected in permanent equity.

Our unaudited condensed consolidated balance sheet reflects the cash and cash equivalents, investments, other assets and liabilities of those sponsored investment products we consolidate, as well as redeemable non-controlling interests for the portion of these sponsored investment products that are held by unrelated third-party investors. Although we can redeem our net interest in these sponsored investment products at any time, we cannot directly access or sell the assets held by the products to obtain cash for general operations. Additionally, the assets of these sponsored investment products are not available to our general creditors. Our interest in these sponsored investment products was generally used as initial seed capital and is recategorized as discretionary when it is determined by management that the seed capital is no longer needed. We assess the discretionary investment products and, when we decide to liquidate our interest, we seek to do so in a way as to not impact the product and, ultimately, the unrelated third-party investors.

Uses of Liquidity

We increased our quarterly recurring dividend per common share in February 2024 by 1.6% to \$1.24 per common share from \$1.22 per common share. Further, we expended \$80.1 million \$192.4 million in the first quarter half of 2024 to repurchase 717 thousand 1.7 million shares of our outstanding common stock, at an average price of \$111.11 \$114.23 per share. These dividends and repurchases were expended using existing cash balances and cash generated from operations. While opportunistic in our approach to stock buybacks, we will generally repurchase our common stock over time to offset the dilution created by our equity-based compensation plans.

Operating Activities

Operating activities attributable to T. Rowe Price Group during the first quarter half of 2024 provided cash flows of \$739.5 million \$1,470.4 million, an increase of \$66.8 million \$209.4 million from \$672.7 million \$1,261.0 million during the 2023 period. The increase was primarily driven by a \$152.3 million \$159.3 million increase in net income. This was income and an \$89.8 million increase in the add-back for non-cash items. The details of our non-cash adjustments are detailed in the table above. These increases to operating cash flows were offset in part by a higher reduction of operating \$36.4 million decrease in cash flows of \$17.9 million from non-cash items and by a \$64.3 million decrease in flow due to timing differences related to the cash settlement of our assets and liabilities. The details of our non-cash adjustments are detailed in the table above. Additionally, in 2024, we made \$3.3 million in more proceeds from net redemptions of investments in certain investment products that economically hedge our supplemental savings plan liability. liability decreased \$3.3 million as compared to the 2023 period. The remaining change in reported cash flows from operating activities was attributable to the net change in trading securities held in our consolidated investment products' underlying portfolios.

Our interim operating cash flows does not include the cash impact of variable compensation that is accrued throughout the year before being substantially paid out in December.

Investing Activities

Net cash used in investing activities that were attributable to T. Rowe Price Group totaled \$34.4 million \$75.7 million in 2024 compared with \$52.0 million \$163.5 million in 2023. During 2024, net proceeds from the sale of investments of \$65.3 million \$172.0 million were higher compared to \$9.3 million \$1.1 million during the 2023 period. In 2024, we increased our property and equipment expenditures by \$41.8 million \$73.4 million and decreased our other investing activity by \$3.4 million \$9.7 million compared to the 2023 period. We eliminate our capital in those sponsored investment products we consolidate in preparing our consolidated statements of cash flows. The remaining change in reported cash flows from investing activities of \$2.4 million \$4.7 million is primarily related to the net cash removed from our balance sheet from consolidating and deconsolidating investment products.

Financing Activities

Net cash used in financing activities attributable to T. Rowe Price Group totaled \$355.2 million \$746.4 million in 2024 compared with \$282.2 million \$603.4 million in 2023. During 2024, we used \$83.1 million \$195.5 million to repurchase 0.7 million 1.7 million shares compared to \$8.2 million \$45.2 million to repurchase 25,420 thousand shares in 2023. The \$4.3 million \$7.3 million increase in dividends paid in 2024 is a result of the 1.6% increase in our quarterly dividend per share in 2024. In addition, cash flow related to common stock issued under stock compensation plans increased by \$6.2 million \$4.2 million during 2024 compared to 2023. The remaining change in reported cash flows from financing activities is primarily attributable to a \$50.6 million \$112.5 million increase in net subscriptions from redeemable non-controlling interest holders of our consolidated investment products during 2024.

Making these estimates and judgments requires the analysis of information concerning events that may not yet be complete and of facts and circumstances that may change over time. Accordingly, actual amounts or future results can differ materially from those estimates that we include currently in our unaudited condensed consolidated financial statements, significant accounting policies, and notes.

Rowe Price mutual funds and other managed investment products as compared with competing offerings and market indexes; the ability to maintain our investment management and administrative fees at appropriate levels; the impact of changes in interest rates and inflation; competitive conditions in the mutual fund, asset management, and broader financial services sectors; our level of success in implementing our strategy to expand our business; and our ability to attract and retain key personnel. Our revenues are substantially dependent on fees earned under contracts with the T. Rowe Price funds and could be adversely affected if the independent directors of one or more of the T.
