share. The gross proceeds to the Company from this offering are approximately \$6.0 million before deducting the
placement agent's fees and other offering expenses. This offering was effected pursuant to Securities Purchase
Agreements, each dated as of January 30, 2025 (the â€œPurchase Agreementsâ€), entered into between the Company
