As announced in the CSN Day presentation published on December 11, 2024 in the category Notice to the Market, this mini-overhaul of BF#2 aims to modernize and extend the useful life of the asset, extending its operation by 8 years, without requiring additional costs and/or investments to the official projections already anticipated by the Company for this year. CSN also clarifies that the mini-overhaul is part of its maintenance program and has been duly planned so as not to affect the results of the Steel segment and its customers.
