With this appointment, the interim management committee has been dissolved. Â On the same day, the Companyâ€™s board of directors approved and declared a special cash dividend of US\$9.94 per ordinary share, or US\$9.94 per American Depositary Share (â€œADSâ€), to holders of record of ordinary shares and ADSs as of the close of business on FebruaryÂ 10, 2025. Â The aggregate amount of cash dividends to be paid will be approximately US\$300 million and is expected to be paid on or around FebruaryÂ 20, 2025, for holders of ordinary shares and holders of ADSs. Holders of the Company's ADSs will receive the cash dividends through JPMorgan Chase Bank, N.A., the depositary, subject to the terms and conditions of the deposit agreement. As part of our strategic cash management and allocation, our Board of Directors has approved a special cash dividend of approximately US\$300 million.
