Available seat miles - represents the aircraft seating capacity multiplied by the number of miles the seats are flown. 2. Revenue passenger miles - represents the number of miles flown by revenue passengers. 3. Load factor - represents the percentage of aircraft seating capacity that is actually utilized. For January 2025, Copa Holdings' capacity (ASMs) increased by 22.1%, while system-wide passenger traffic (RPMs) increased by 23.6%, compared to 2024. As a result, the system load factor for the month was 86.4%, 1.1 percentage points higher than in January 2024. These results include the effect of the partial grounding of the Company's Boeing 737 MAX-9 fleet in January 2024. Copa Holdings is a leading Latin American provider of passenger and cargo services.
