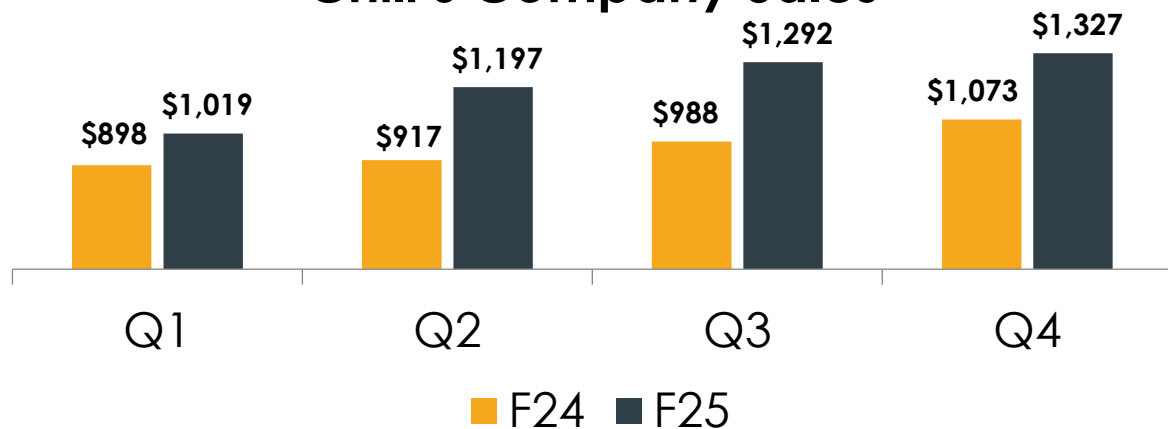

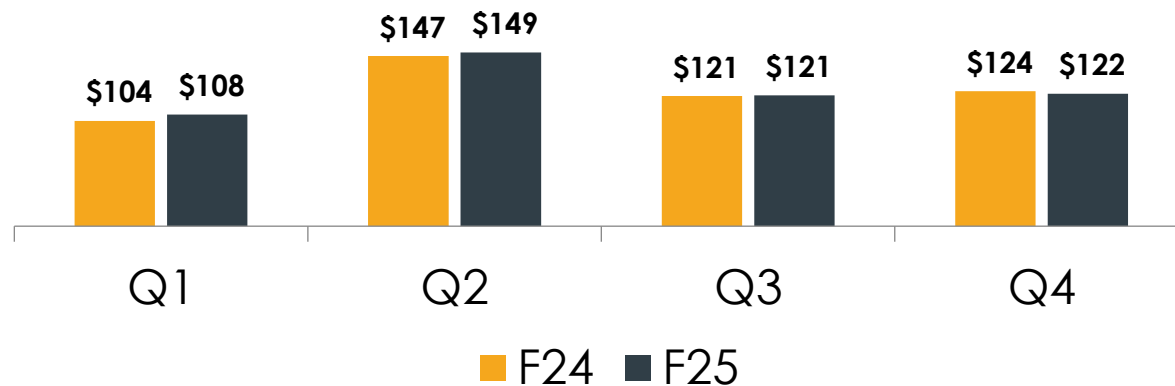


BRINKER SALES AND REVENUE*

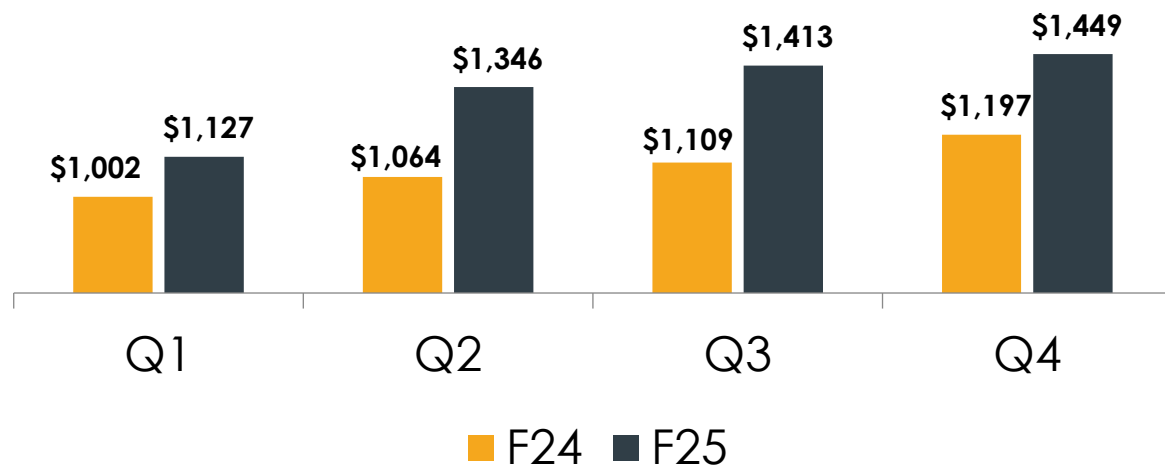
Chili's Company Sales



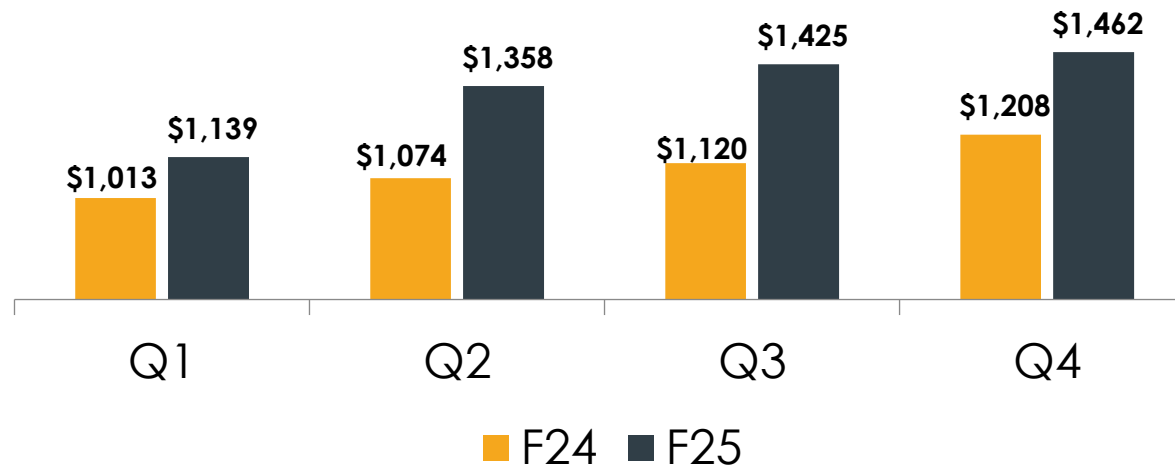
Maggiano's Company Sales



Total Company Sales



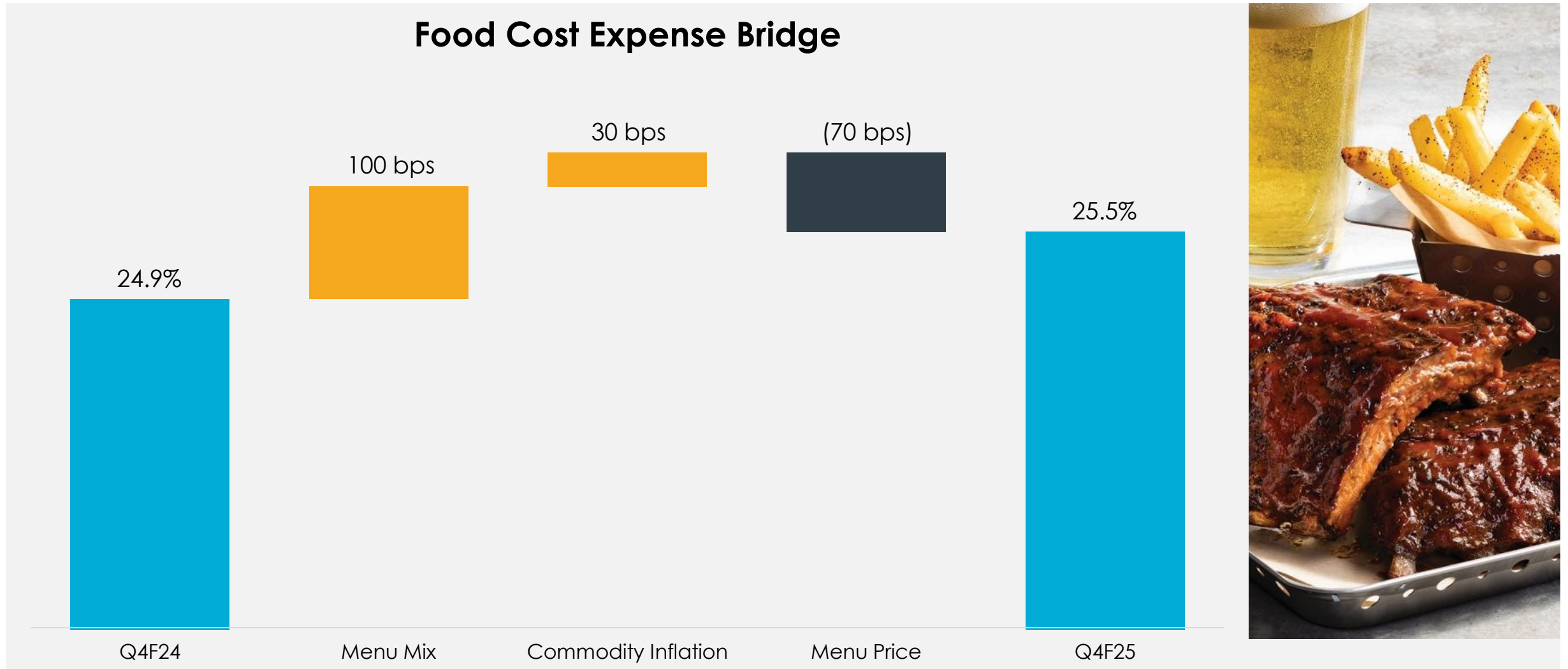
Total Revenues

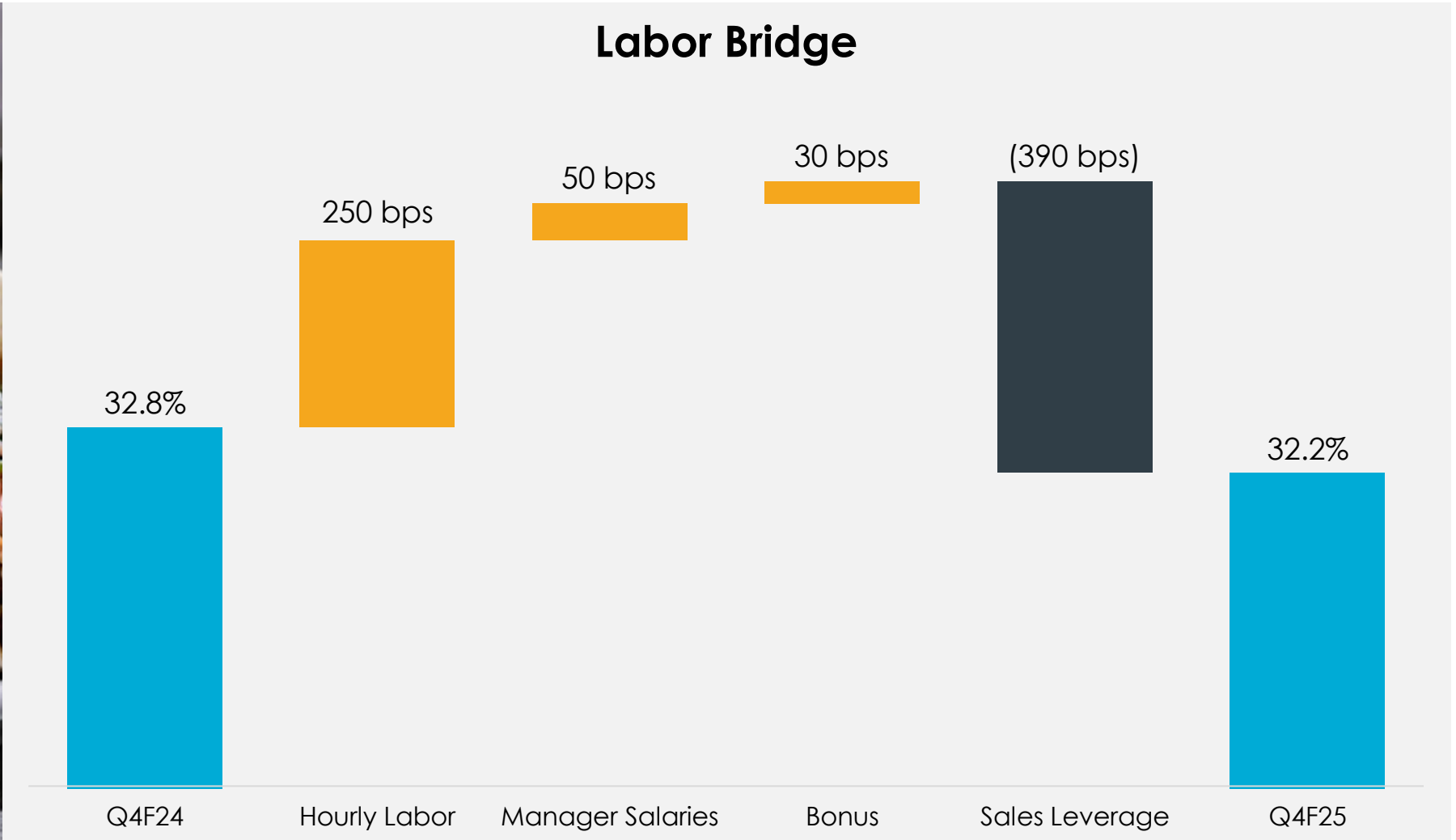


Q4 FOOD COST HIGHER DUE TO UNFAVORABLE MENU MIX
