Other Events On September 18, 2024, the board of directors (the â€œBoardâ€) of AerCap Holdings N.V. (â€œAerCapâ€) approved a share repurchase program authorizing total repurchases of up to \$500 million of AerCap ordinary shares through March 31, 2025 (the â€œShare Repurchase Programâ€).Â This program is in addition to the \$105 million of capacity remaining under the share repurchase program announced on May 8, 2024, which runs through December 31, 2024. Repurchases under the Share Repurchase Program may be made through open market purchases or privately negotiated transactions in accordance with applicable U.S. federal securities laws. The timing of repurchases and the exact number of ordinary shares to be purchased will be determined by AerCapâ€™s management, in its discretion, and will depend upon market conditions and other factors. The Share Repurchase Program will be funded using AerCapâ€™s cash on hand and cash generated from operations. The Share Repurchase Program may be suspended or discontinued at any time.
