Capitalized terms used and not otherwise defined herein shall have the meanings specified in the Indenture or the Supplemental Indenture, as applicable. Pursuant to SectionÂ 10.1 of the Indenture and SectionÂ 3.1 of the Supplemental Indenture, YPF will redeem in full the aggregate principal amount of Notes outstanding on the Redemption Date at a redemption price equal to 100.00% of the principal amount of such Notes, which amount is equal to \$1,000 per \$1,000 principal amount thereof, plus the Applicable Redemption Premium as of, and accrued and unpaid interest and Additional Amounts thereon, if any, to (but not including) the Redemption Date (the â€œRedemption Priceâ€). Payment of interest on the Notes and Additional Amounts, if any, will be paid as specified in this notice. Unless YPF defaults in paying the Redemption Price or any of any amounts due and owing under the Notes, interest on Notes called for redemption ceases to accrue on and after the Redemption Date. Payment on the Notes will be made on the Redemption Date by payment of the Redemption Price on the Business Day prior to the Redemption Date to the account of the Trustee, as paying agent under the Notes (the â€œPaying Agentâ€). The Paying Agent will cause funds to be paid to The Depository Trust Company for further payment to its participants. Payments made in redemption of Notes may be subject to information reporting and backup withholding of U.S. federal income tax, currently at a rate of 24%. Certain investors are not subject to these information reporting and backup withholding requirements. To avoid backup withholding, an investor who is a â€œUnited States personâ€ (as defined in the Internal Revenue Code) that does not otherwise establish an exemption should provide an IRS Form W-9, certifying that it is a United States person, that the taxpayer identification number provided is correct, and that it is not subject to backup withholding.
