Innoviz Regains Compliance with Nasdaqâ™s Minimum Bid Price Requirement Tel Aviv, ISRAEL  January 2, 2025  Innoviz Technologies Ltd. (Nasdaq: INVZ) (the âœCompanyâ€ or âœInnovizâ€), a leading Tier-1 direct supplier of high-performance, automotive-grade LiDAR sensors and perception software, today announced that it received formal written confirmation from The Nasdaq Stock Market, LLC (âœNasdaqâ€) confirming that the Company has regained compliance with Nasdaqâ™s minimum bid price requirement.  The regaining of compliance is a result of the Companyâ™s closing bid price of the Companyâ™s ordinary shares (the âœSharesâ€) being at least \$1.00 for at least 10 consecutive business days prior to January 27, 2025 deadline, as described in the initial notice from Nasdaq to the Company dated July 30, 2024.  The closing bid price of the Shares has been at \$1.00 per Share or greater for 10 consecutive business days from December 16 to December 30, 2024. Accordingly, Nasdaq Listing Qualifications Staff has notified the Company that it has determined that the Company has regained compliance with Nasdaq Listing Rule 5550(a)(2), and the matter is now closed.
