NOTES TO CONSOLIDATED FINANCIAL STATEMENTS

1. Description of Business

Ralph Lauren Corporation ("RLC") is a global leader in the design, marketing, and distribution of luxury lifestyle products, including apparel, footwear & accessories, home, fragrances, and hospitality. RLC's long-standing reputation and distinctive image have been developed across a wide range of products, brands, distribution channels, and international markets. RLC's brand names include Ralph Lauren, Ralph Lauren Collection, Ralph Lauren Purple Label, Double RL, Polo Ralph Lauren, Lauren Ralph Lauren, Polo Ralph Lauren Children, and Chaps, among others. RLC and its subsidiaries are collectively referred to herein as the "Company," "we," "us," "our," and "ourselves," unless the context indicates otherwise.

The Company diversifies its business by geography (North America, Europe, and Asia, among other regions) and channel of distribution (retail, wholesale, and licensing). This allows the Company to maintain a dynamic balance as its operating results do not depend solely on the performance of any single geographic area or channel of distribution. The Company sells directly to consumers through its integrated retail channel, which includes its retail stores, concession-based shop-within-shops, and digital commerce operations around the world. The Company's wholesale sales are made principally to major department stores, specialty stores, and third-party digital partners around the world, as well as to certain third-party-owned stores to which the Company has licensed the right to operate in defined geographic territories using its trademarks. In addition, the Company licenses to third parties for specified periods the right to access its various trademarks in connection with the licensees' manufacture and sale of designated products, such as certain apparel, eyewear, fragrances, and home furnishings.

The Company organizes its business into the following three reportable segments: North America, Europe, and Asia. In addition to these reportable segments, the Company also has other non-reportable segments. See Note 16 for further discussion of the Company's segment reporting structure.

2. Basis of Presentation

Interim Financial Statements

These interim consolidated financial statements have been prepared in accordance with the rules and regulations of the Securities and Exchange Commission (the "SEC") and are unaudited. In the opinion of management, these consolidated financial statements contain all normal and recurring adjustments necessary to present fairly the consolidated financial position, income (loss), comprehensive income (loss), and cash flows of the Company for the interim periods presented. In addition, certain information and disclosures normally included in financial statements prepared in accordance with accounting principles generally accepted in the U.S. ("U.S. GAAP") and the notes thereto have been condensed or omitted from this report as is permitted by the SEC's rules and regulations. However, the Company believes that the disclosures provided herein are adequate to prevent the information presented from being misleading.

This report should be read in conjunction with the Company's Annual Report on Form 10-K filed with the SEC for the fiscal year ended March 30, 2024 (the "Fiscal 2024 10-K").

Basis of Consolidation

These unaudited interim consolidated financial statements present the consolidated financial position, income (loss), comprehensive income (loss), and cash flows of the Company, including all entities in which the Company has a controlling financial interest and is determined to be the primary beneficiary. All significant intercompany balances and transactions have been eliminated in consolidation.

Fiscal Periods

The Company utilizes a 52-53 week fiscal year ending on the Saturday closest to March 31. As such, fiscal year 2025 will end on March 29, 2025 and will be a 52-week period ("Fiscal 2025"). Fiscal year 2024 ended on March 30, 2024 and was also a 52-week period ("Fiscal 2024"). The **second third** quarter of Fiscal 2025 ended on **September 28, 2024** **December 28, 2024** and was a 13-week period. The **second third** quarter of Fiscal 2024 ended on **September 30, 2023** **December 30, 2023** and was also a 13-week period.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make certain estimates and assumptions that affect the amounts reported in the financial statements and notes thereto. Actual results could differ materially from those estimates.

Significant estimates inherent in the preparation of the consolidated financial statements include reserves for customer bad debt, customer returns, discounts, end-of-season markdowns, operational chargebacks, and certain cooperative advertising allowances; the realizability of inventory; reserves for litigation and other contingencies; useful lives and impairments of long-lived tangible and intangible assets; fair value measurements; accounting for income taxes and related uncertain tax positions; valuation of stock-based compensation awards and related forfeiture rates; and reserves for restructuring activity, among others.

Reclassifications

Certain reclassifications have been made to the prior periods' financial information in order to conform to the current period's presentation.

Seasonality of Business

The Company's business is typically affected by seasonal trends, with higher levels of retail sales in its second and third fiscal quarters and higher wholesale sales in its second and fourth fiscal quarters. These trends result primarily from the timing of key vacation travel, back-to-school, and holiday shopping periods impacting its retail business and the timing of seasonal wholesale shipments. As a result of changes in its business, consumer spending patterns, and the macroeconomic environment, including those resulting from pandemic diseases and other catastrophic events, historical quarterly operating trends and working capital requirements may not be indicative of the Company's future performance. In addition, fluctuations in sales, operating income (loss), and cash flows in any fiscal quarter may be affected by other events affecting retail sales, such as changes in weather patterns. Accordingly, the Company's operating results and cash flows for the three-month and **six-month** **nine-month** periods ended **September 28, 2024** **December 28, 2024** are not necessarily indicative of the operating results and cash flows that may be expected for the full Fiscal 2025.

3. Summary of Significant Accounting Policies

Revenue Recognition

The Company recognizes revenue across all channels of the business when it satisfies its performance obligations by transferring control of promised products or services to its customers, which occurs either at a point in time or over time, depending on when the customer obtains the ability to direct the use of and obtain substantially all of the remaining benefits from the products or services. The amount of revenue recognized considers terms of sale that create variability in the amount of consideration that the Company ultimately expects to be entitled to in exchange for the products or services, and is subject to an overall constraint that a significant revenue reversal will not occur in future periods. Sales and other related taxes collected from customers and remitted to government authorities are excluded from revenue.

Revenue from the Company's retail business is recognized when the customer takes physical possession of the products, which occurs either at the point of sale for merchandise purchased at the Company's own retail stores and shop-within-shop locations, or upon receipt of shipment for merchandise ordered through direct-to-consumer digital commerce sites. Such revenues are recorded net of estimated returns based on historical trends. Payment is due at the point of sale.

Gift cards purchased by customers are recorded as a liability until they are redeemed for products sold by the Company's retail business, at which point revenue is recognized. The Company also estimates and recognizes revenue for gift card balances not expected to ever be redeemed (referred to as "breakage") to the extent that it does not have a legal obligation to remit the value of such unredeemed gift cards to the relevant jurisdiction as unclaimed or abandoned property. Such estimates are based upon historical redemption trends, with breakage income recognized in proportion to the pattern of actual customer redemptions.

Revenue from the Company's wholesale business is generally recognized upon shipment of products, at which point title passes and risk of loss is transferred to the customer. In certain arrangements where the Company retains the risk of loss during shipment, revenue is recognized upon receipt of products by the customer. Wholesale revenue is recorded net of estimates of returns, discounts, end-of-season markdowns, operational chargebacks, and certain cooperative advertising allowances. Returns and allowances require pre-approval from management and discounts are based on trade terms. Estimates for end-of-season markdown reserves are based on historical trends, actual and forecasted seasonal results, an evaluation of current economic and market conditions, retailer performance, and, in certain cases, contractual terms. Estimates for operational chargebacks are based on actual customer notifications of order fulfillment discrepancies and historical trends. The Company reviews and refines these estimates on at least a quarterly basis. The Company's historical estimates of these amounts have not differed materially from actual results.

Revenue from the Company's licensing arrangements is recognized over time during the period that licensees are provided access to the Company's trademarks (i.e., symbolic intellectual property) and benefit from such access through their own sales of licensed products. These arrangements require licensees to pay a sales-based royalty, which for most arrangements, may be subject to a contractually-guaranteed minimum royalty amount. Payments are generally due quarterly and, depending on time of receipt, may be recorded as a liability until recognized as revenue. The Company recognizes revenue for sales-based royalty arrangements (including those for which the royalty exceeds any contractually-guaranteed minimum royalty amount) as licensed products are sold by the licensee. If a sales-based royalty is not ultimately expected to exceed a contractually-guaranteed minimum royalty amount, the minimum is generally recognized as revenue ratably over the respective contractual period. This sales-based output measure of progress and pattern of recognition best represents the value transferred to the licensee over the term of the arrangement, as well as the amount of consideration that the Company is entitled to receive in exchange for providing access to its trademarks. As of **September 28, 2024** **December 28, 2024**, contractually-guaranteed minimum royalty amounts expected to be recognized as revenue during future periods were as follows:

(a) Net revenues from the Company's retail and wholesale businesses are recognized at a point in time. Net revenues from the Company's licensing business are recognized over time.

Deferred Income

Deferred income represents cash payments received in advance of the Company's transfer of control of products or services to its customers and generally consists of unredeemed gift cards (net of breakage) and advance royalty payments from its licensees. The Company's deferred income balances were \$15.8 million, \$22.6 million and \$17.4 million as of September 28, 2024, December 28, 2024 and March 30, 2024, respectively, and were primarily recorded within accrued expenses and other current liabilities within the consolidated balance sheets. The majority of the deferred income balance as of September 28, 2024, December 28, 2024 is expected to be recognized as revenue within the next twelve months.

Shipping and Handling Costs

Costs associated with shipping goods to customers are accounted for as fulfillment activities and reflected as selling, general, and administrative ("SG&A") expenses in the consolidated statements of operations. Costs of preparing merchandise for sale, such as picking, packing, warehousing, and order charges ("handling costs"), are also included in SG&A expenses. Shipping and handling costs billed to customers are included in revenue.

Accounts Receivable

In the normal course of business, the Company extends credit to wholesale customers that satisfy certain defined credit criteria. Payment is generally due within 30 to 120 days and does not involve a significant financing component. Accounts receivable are recorded at amortized cost, which approximates fair value, and are presented in the consolidated balance sheets net of certain reserves and allowances. These reserves and allowances consist of (i) reserves for returns, discounts, end-of-season markdowns, operational chargebacks, and certain cooperative advertising allowances (see the "Revenue Recognition" section above for further discussion of related accounting policies) and (ii) allowances for doubtful accounts.

Concentration of Credit Risk

The Company sells its wholesale merchandise primarily to major department stores, specialty stores, and third-party digital partners around the world, and extends credit based on an evaluation of each customer's financial capacity and condition, usually without requiring collateral. In the Company's wholesale business, concentration of credit risk is relatively limited due to the large number of customers and their dispersion across many geographic areas. However, the Company has three key wholesale customers that generate significant sales volume. During Fiscal 2024, the Company's sales to these three customers accounted for approximately 13% of total net revenues. Substantially all of the Company's sales to its three largest wholesale customers related to its North America segment. As of **September 28, 2024** **December 28, 2024**, these three wholesale customers accounted for approximately **28%** **22%** of total gross accounts receivable.

Inventories

The Company holds inventory that is sold in its retail stores and digital commerce sites directly to consumers. The Company also holds inventory that is to be sold through wholesale distribution channels to major department stores, specialty stores, and third-party digital partners. Substantially all of the Company's inventories consist of finished goods, which are stated at the lower of cost or estimated realizable value, with cost determined on a weighted-average cost basis. Inventory held by the Company totaled **\$1.128 billion** **\$998.6 million**, \$902.2 million, and **\$1.195 billion** **\$1.055 billion** as of **September 28, 2024** **December 28, 2024**, March 30, 2024, and **September 30, 2023** **December 30, 2023**, respectively.

Supplier Finance Program

The Company supports a voluntary supplier finance program which provides certain of its inventory suppliers the opportunity, at their sole discretion, to sell their receivables due from the Company (which are generally due within 90 days) to a participating financial institution in exchange for receipt of a discounted payment amount made earlier than the payment term stipulated between the Company and the supplier. The Company's vendor payment terms and amounts due are not impacted by a supplier's decision to participate in the program. The Company has not pledged any assets and does not provide guarantees under the supplier finance program. The Company's payment obligations outstanding under its supplier finance program were **\$215.5 million** **\$216.2 million** and \$129.2 million as of **September 28, 2024** **December 28, 2024** and March 30, 2024, respectively, and were recorded within accounts payable in the consolidated balance sheets.

Derivative Financial Instruments

The Company records derivative financial instruments on its consolidated balance sheets at fair value. Changes in the fair value of derivative instruments that are designated and qualify for hedge accounting are either (i) offset through earnings against the changes in fair value of the related hedged assets, liabilities, or firm commitments or (ii) recognized in equity as a component of accumulated other comprehensive income (loss) ("AOCI") until the hedged item is recognized in earnings, depending on whether the instrument is hedging against changes in fair value or cash flows and net investments, respectively.

Each derivative instrument that qualifies for hedge accounting is expected to be highly effective in offsetting the risk associated with the related exposure. For each instrument that is designated as a hedge, the Company documents the related risk management objective and strategy, including identification of the hedging instrument, the hedged item, and the risk exposure, as well as how hedge effectiveness will be assessed over the instrument's term. To assess hedge effectiveness at the inception of a hedging relationship, the Company generally uses regression analysis, a statistical method, to evaluate how changes in the fair value of the derivative instrument are expected to offset changes in the fair value or cash flows of the related hedged item. The extent to which a hedging instrument has been and is expected to remain highly effective in achieving offsetting changes in fair value or cash flows is assessed by the Company on at least a quarterly basis.

Given its use of derivative instruments, the Company is exposed to the risk that counterparties to such contracts will fail to meet their contractual obligations. To mitigate such counterparty credit risk, the Company's policy is to only enter into contracts with carefully selected financial institutions based upon an evaluation of their credit ratings and certain other factors, adhering to established limits for credit exposure. The Company's established policies and procedures for mitigating credit risk include ongoing review and assessment of its counterparties' creditworthiness. The Company also enters into master netting arrangements with counterparties, when possible, to further mitigate credit risk. In the event of default or termination, these arrangements allow the Company to net-settle amounts payable and receivable related to multiple derivative transactions with the same counterparty. The master netting arrangements specify a number of events of default and termination, including the failure to make timely payments.

The fair values of the Company's derivative instruments are recorded on its consolidated balance sheets on a gross basis. For cash flow reporting purposes, proceeds received or amounts paid upon the settlement of a derivative instrument are classified in the same manner as the related item being hedged, primarily within cash flows from operating activities for its forward foreign exchange contracts and within cash flows from investing activities for its cross-currency swap contracts, both as discussed below.

Cash Flow Hedges

The Company uses forward foreign currency exchange contracts to mitigate its risk related to exchange rate fluctuations on inventory transactions made in an entity's non-functional currency. To the extent designated as cash flow hedges, related gains or losses on such instruments are initially deferred in equity as a component of AOCI and are subsequently recognized within cost of goods sold in the consolidated statements of operations when the related inventory is sold.

If a derivative instrument is dedesignated or if hedge accounting is discontinued because the instrument is not expected to be highly effective in hedging the designated exposure, any further gains (losses) are recognized in earnings each period within other income (expense), net. Upon discontinuance of hedge accounting, the cumulative change in fair value of the derivative instrument recorded in AOCI is recognized in earnings when the related hedged item affects earnings, consistent with the hedging strategy, unless the related forecasted transaction is probable of not occurring, in which case the accumulated amount is immediately recognized within other income (expense), net.

Hedges of Net Investments in Foreign Operations

The Company periodically uses cross-currency swap contracts to reduce risk associated with exchange rate fluctuations on certain of its net investments in foreign subsidiaries. Changes in the fair values of such derivative instruments that are designated as hedges of net investments in foreign operations are recorded in equity as a component of AOCI in the same manner as foreign currency translation adjustments. In assessing the effectiveness of such hedges, the Company uses a method based on changes in spot rates to measure the impact of foreign currency exchange rate fluctuations on both its foreign subsidiary net investment and the related hedging instrument. Under this method, changes in the fair value of the hedging instrument other than those due to changes in the spot rate are initially recorded in AOCI as a translation adjustment and are amortized into earnings as interest expense using a systematic and rational method over the instrument's term. Changes in fair value associated with the effective portion (i.e., those due to changes in the spot rate) are recorded in AOCI as a translation adjustment and are released and recognized in earnings only upon the sale or liquidation of the hedged net investment.

Undesignated Hedges

The Company uses undesignated hedges primarily to hedge foreign currency exchange rate risk related to third-party and intercompany balances and exposures. Changes in the fair values of such instruments are recognized in earnings each period within other income (expense), net.

Improvements to Disaggregation of Income Tax Disclosures Statement Expenses

In December 2023, November 2024, the Financial Accounting Standards Board ("FASB") issued Accounting Standards Update ("ASU") No. 2024-03, "Disaggregation of Income Statement Expenses" ("ASU 2024-03"). ASU 2024-03 requires interim and annual tabular disclosure of disaggregated information for certain income statement expense captions. Specific expense categories required to be disclosed quantitatively include inventory purchases, employee compensation, depreciation, and intangible asset amortization, as well as other specified expense categories currently disclosed under existing disclosure requirements. Additionally, any remaining amounts that are not separately disaggregated are required to be described qualitatively. ASU 2024-03 also requires separate disclosure of total selling expenses incurred each reporting period, with annual disclosure of the entity's definition of selling expenses. The annual disclosures required by ASU 2024-03 are effective for the Company beginning in its fiscal year ending April 1, 2028 ("Fiscal 2028"), with interim disclosures effective beginning in its fiscal year ending March 31, 2029 ("Fiscal 2029"). The provisions of ASU 2024-03 are to be applied prospectively, although retrospective application is permitted. Early adoption is also permitted. Other than the new disclosure requirements, ASU 2024-03 will not have an impact on the Company's consolidated financial statements.

Improvements to Income Tax Disclosures

In December 2023, the FASB issued ASU No. 2023-09, "Improvements to Income Tax Disclosures" ("ASU 2023-09"). ASU 2023-09 is intended to enhance the transparency and usefulness of annual income tax disclosures. Among its provisions, ASU 2023-09 requires disclosure of a reconciliation between an entity's effective tax rate, which is calculated by dividing each fiscal period's income tax provision by pretax income, and its statutory rate utilizing eight specific categories, along with a separate disclosure for reconciling items that meet a 5% quantitative threshold. In addition, ASU 2023-09 requires disclosure of income taxes paid (net of refunds received), disaggregated by federal, state, and foreign taxes, as well as by individual jurisdictions if a 5% quantitative threshold is met. ASU 2023-09 is effective for the Company for annual periods beginning with its fiscal year ending March 28, 2026 ("Fiscal 2026") and is to be applied prospectively, although retrospective application is permitted. Early adoption is also permitted. Other than the new disclosure requirements, ASU 2023-09 will not have an impact on the Company's consolidated financial statements.

Improvements to Reportable Segment Disclosures

In November 2023, the FASB issued ASU No. 2023-07, "Improvements to Reportable Segment Disclosures" ("ASU 2023-07"). ASU 2023-07 requires entities to make certain enhanced segment disclosures on both an annual and interim basis, including disclosure of significant segment expenses that are regularly provided to their chief operating decision maker (the "CODM") as defined within Accounting Standards Codification Topic 280, "Segment Reporting," as well as various information about an entity's CODM, among other provisions. ASU 2023-07 does not change how entities identify their operating segments, aggregate them, or apply the quantitative thresholds to determine their reportable segments. The annual disclosures required by ASU 2023-07 are effective for the Company beginning in Fiscal 2025, with interim disclosures effective beginning in Fiscal 2026. 7. Restructuring and Other Charges, Net

A description of significant restructuring and other activities and their related costs is provided below.

Fiscal 2025 Restructuring Activities

During the three-month and six-month periods ended September 28, 2024, the Company recorded \$7.4 million cash-related restructuring benefits of \$0.2 million during the three months ended December 28, 2024 and \$10.7 million, respectively, of cash-related restructuring charges of \$10.5 million during the nine months ended December 28, 2024, primarily associated with severance and benefit costs. As of September 28, 2024 December 28, 2024, the remaining liability related to these cash-related charges was \$7.9 million \$6.5 million, reflecting cash payments of \$2.8 million \$3.8 million and non-cash adjustments of \$0.2 million made during the six nine months ended September 28, 2024 December 28, 2024. The Company also recorded non-cash-related charges, net of \$1.6 million \$1.8 million and \$3.4 million, respectively, during the three-month and six-month nine-month periods ended September 28, 2024 December 28, 2024, primarily related to stock-based compensation expense recorded in connection with an employment separation agreement.

Fiscal 2024 Restructuring Activities

During the three-month and six-month nine-month periods ended September 30, 2023 December 30, 2023, the Company recorded \$6.8 million \$1.0 million and \$37.3 million \$38.3 million, respectively, of cash-related restructuring charges, primarily associated with severance and benefit costs. During Fiscal 2024, the Company recorded cumulative restructuring-related charges of \$55.8 million, comprised of cash-related charges of \$54.5 million, primarily associated with severance and benefit costs, and non-cash-related charges of \$1.3 million. As of September 28, 2024 December 28, 2024 and March 30, 2024, the remaining liability related to these cash-related charges was \$15.5 million \$10.9 million

Other Restructuring Activities

During the three-month and six-month nine-month periods ended September 28, 2024 December 28, 2024, the Company recognized \$0.4 million \$0.7 million and \$1.4 million \$2.1 million, respectively, of income within restructuring and other charges, net in the consolidated statements of operations related to consideration received from Regent, L.P. in connection with the Company's previously sold Club Monaco business. On a comparative basis, during the three-month and six-month nine-month periods ended September 30, 2023 December 30, 2023, the Company recognized \$2.0 million \$5.0 million and \$7.0 million, respectively, of income within restructuring and other charges, net in the consolidated statements of operations related to consideration received from Regent, L.P. in connection with the Company's previously sold Club Monaco business. Refer to Note 9 of the Fiscal 2024 10-K for additional discussion regarding the Company's sale of its former Club Monaco business.

As of September 28, 2024 December 28, 2024 and March 30, 2024, the remaining liability related to the Company's restructuring plans initiated prior to its Fiscal 2024 was \$2.6 million \$1.3 million and \$4.2 million, respectively, reflecting cash payments of \$1.6 million \$2.9 million made during the six nine months ended September 28, 2024 December 28, 2024.

Other Charges

Next Generation Transformation Project

The Company is in the early stages of executing a large-scale, multi-year global project that is expected to significantly transform the way in which the Company operates its business and further enable its long-term strategic pivot towards a global direct-to-consumer-oriented model (the "Next Generation Transformation project" or "NGT project"). The NGT project will be completed in phases and involves the redesigning of certain end-to-end processes and the implementation of a suite of information systems on a global scale. Such efforts are expected to result in significant process improvements and the creation of synergies across core areas of operations, including merchandise buying and planning, procurement, inventory management, retail and wholesale operations, and financial planning and reporting, better enabling the Company to optimize inventory levels and increase

the speed with which it reacts to changes in consumer demand across markets, among other benefits. In connection with the preliminary phase of the NGT project, the Company recorded other charges of \$5.7 million \$9.1 million and \$8.0 million, respectively, \$17.1 million during the three-month and six-month nine-month periods ended September 28, 2024.

The Company recorded other charges of \$4.1 million \$2.2 million and \$6.9 million \$9.1 million during the three-month and six-month nine-month periods ended September 28, 2024 December 28, 2024, respectively, and \$4.5 million \$4.7 million and \$9.6 million \$14.3 million during the three-month and six-month nine-month periods ended September 30, 2023 December 30, 2023, respectively, primarily related to rent and occupancy costs associated with certain previously exited real estate locations in connection with the Company's past restructuring activities for which the related lease agreements have not yet expired.

8. Income Taxes*Effective Tax Rate*

The Company's effective tax rate, which is calculated by dividing each fiscal period's income tax provision by pretax income, was 21.4% 22.5% and 21.8% 22.1% during the three-month and six-month nine-month periods ended September 28, 2024 December 28, 2024, respectively, and 11.2% 16.1% and 17.0% 16.6% during the three-month and six-month nine-month periods ended September 30, 2023 December 30, 2023, respectively. The effective tax rates for the three-month and six-month nine-month periods ended September 28, 2024 December 28, 2024 were slightly higher than the U.S. federal statutory income tax rate of 21% primarily due to uncertain tax positions and state taxes, partially offset by the a favorable tax impact adjustment related to the revaluation of stock-based compensation, a deferred tax liability on foreign earnings. The effective tax rates for the three-month and six-month nine-month periods ended September 30, 2023 December 30, 2023 were lower than the U.S. federal statutory income tax rate of 21% primarily due to deferred tax benefits recognized as a result of transactions entered into as part of a reorganization of the Company's legal entity structure and as a result of changes in tax legislation. The lower effective tax rate for the nine months ended December 30, 2023 was also driven by favorable adjustments related to the revaluation of deferred tax assets arising from Swiss tax reform and favorable deferred tax adjustments related to the European Union's anti-tax avoidance directive. The lower effective tax rates were also driven by favorable remeasurements of net deferred tax assets as a result of enacted changes in tax legislation.

Uncertain Income Tax Benefits

The Company classifies interest and penalties related to unrecognized tax benefits as part of its income tax provision. The total amount of unrecognized tax benefits, including interest and penalties, was \$132.7 million \$170.6 million and \$118.7 million as of September 28, 2024 December 28, 2024 and March 30, 2024, respectively, and was included within the non-current liability for unrecognized tax benefits in the consolidated balance sheets.

The total amount of unrecognized tax benefits that, if recognized, would affect the Company's effective tax rate was \$86.2 million \$87.3 million and \$80.1 million as of September 28, 2024 December 28, 2024 and March 30, 2024, respectively.

On August 26, 2024, the U.S. Tax Court issued a decision in Varian Medical Systems, Inc. v. Commissioner related to the Tax Cuts and Jobs Act deduction for certain deemed foreign dividends otherwise subject to the transition tax on unrepatriated earnings of applicable foreign subsidiaries. Based on the Company's evaluation of the technical merits of this decision, it has filed a protective refund claim with the Internal Revenue Service claiming a transition tax refund of \$34.4 million, for which the Company has recorded a corresponding deferred tax asset. However, at this time the Company believes it is more-likely-than-not that the intended refund claim will not be received. Therefore, the Company has recorded an uncertain tax position reserve for the full refund claim of \$34.4 million. Accordingly, on a net basis, this development had no resulting impact to the Company's effective tax rates or its consolidated statements of operations during the three-month and nine-month periods ended December 28, 2024.

Future Changes in Unrecognized Tax Benefits

The total amount of unrecognized tax benefits relating to the Company's tax positions is subject to change based on future events including, but not limited to, settlements of ongoing tax audits and assessments and the expiration of applicable statutes of limitations. Although the outcomes and timing of such events are highly uncertain, the Company does not anticipate that the balance of gross unrecognized tax benefits, excluding interest and penalties, will change significantly during the next twelve months. However, changes in the occurrence, expected outcomes, and timing of such events could cause the Company's current estimate to change materially in the future.

The Company files a consolidated U.S. federal income tax return, as well as tax returns in various state, local, and foreign jurisdictions. The Company is generally no longer subject to examinations by the relevant tax authorities for years prior to its fiscal year ended March 29, 2014.

Senior Notes

In August 2018, the Company completed a registered public debt offering and issued \$400 million aggregate principal amount of unsecured senior notes due September 15, 2025, which bear interest at a fixed rate of 3.750%, payable semi-annually (the "3.750% Senior Notes"). The 3.750% Senior Notes were issued at a price equal to 99.521% of their principal amount. The proceeds from this offering were used for general corporate purposes, including repayment of the Company's previously outstanding \$300 million principal amount of 2.125% unsecured senior notes that matured September 26, 2018.

In June 2020, the Company completed another registered public debt offering and issued an additional \$500 million aggregate principal amount of unsecured senior notes that were due and repaid on June 15, 2022 with cash on hand, which bore interest at a fixed rate of 1.700%, payable semi-annually (the "1.700% Senior Notes"), and \$750 million aggregate principal amount of unsecured senior notes due June 15, 2030, which bear interest at a fixed rate of 2.950%, payable semi-annually (the "2.950% Senior Notes"). The 1.700% Senior Notes and 2.950% Senior Notes were issued at prices equal to 99.880% and 98.995% of their principal amounts, respectively. The proceeds from these offerings were used for general corporate purposes, which included the repayment of \$475 million previously outstanding under the Company's Global Credit Facility (as defined below) on June 3, 2020 and repayment of its previously outstanding \$300 million principal amount of 2.625% unsecured senior notes that matured August 18, 2020.

The Company has the option to redeem the 3.750% Senior Notes and 2.950% Senior Notes (collectively, the "Senior Notes"), in whole or in part, at any time at a price equal to accrued and unpaid interest on the redemption date plus the greater of (i) 100% of the principal amount of the series of Senior Notes to be redeemed or (ii) the sum of the present value of Remaining Scheduled Payments, as defined in the supplemental indentures governing such Senior Notes (together with the indenture governing the Senior Notes, the "Indenture"). The Indenture contains certain covenants that restrict the Company's ability, subject to specified exceptions, to incur certain liens; enter into sale and leaseback transactions; consolidate or merge with another party; or sell, lease, or convey all or substantially all of the Company's property or assets to another party. However, the Indenture does not contain any financial covenants.

Commercial Paper

The Company has a commercial paper borrowing program that allows it to issue up to \$750 million of unsecured commercial paper notes through private placement using third-party broker-dealers (the "Commercial Paper Program").

Borrowings under the Commercial Paper Program are supported by the Global Credit Facility (as defined below). Accordingly, the Company does not expect combined borrowings outstanding under the Commercial Paper Program and Global Credit Facility to exceed \$750 million. Commercial Paper Program borrowings may be used to support the Company's general working capital and corporate needs. Maturities of commercial paper notes vary, but cannot exceed 397 days from the date of issuance. Commercial paper notes issued under the Commercial Paper Program rank equally in seniority with the Company's other forms of unsecured indebtedness. As of both September 28, 2024 December 28, 2024 and March 30, 2024, there were no borrowings outstanding under the Commercial Paper Program.

Revolving Credit Facilities*Global Credit Facility*

In June 2023, the Company terminated its then existing credit facility and entered into a new credit facility that provides for a \$750 million senior unsecured revolving line of credit through June 30, 2028 (the "Global Credit Facility") under terms and conditions substantially similar to those of the previous facility. The Global Credit Facility may be used for working capital needs, capital expenditures, certain investments, general corporate purposes, and for funding of acquisitions. The Global Credit Facility may also be used to support the issuance of letters of credit and maintenance of the Commercial Paper Program. Borrowings under the Global Credit Facility may be denominated in U.S. Dollars and certain other currencies, including Euros, Hong Kong Dollars, and Japanese Yen, and are guaranteed by some of the Company's domestic subsidiaries, including all of the Company's significant subsidiaries. In accordance with the terms of the agreement governing the Global Credit Facility, the Company has the ability to expand its borrowing availability under the Global Credit Facility to \$1.500 billion, subject to the agreement of one or more new or existing lenders under the facility to increase their commitments. There are no mandatory reductions in borrowing ability throughout the term of the Global Credit Facility. As of both September 28, 2024 December 28, 2024 and March 30, 2024, March 30,

2024, there were no borrowings outstanding under the Global Credit Facility. However, the Company was contingently liable for \$11.7 million \$10.6 million and \$11.8 million of outstanding letters of credit as of September 28, 2024 December 28, 2024 and March 30, 2024, respectively.

The Global Credit Facility contains a number of covenants that, among other things, restrict the Company's ability, subject to specified exceptions, to incur additional debt; incur liens; sell or dispose of assets; merge with or acquire other companies; liquidate or dissolve itself; engage in businesses that are not in a related line of business; make loans, advances, or guarantees; engage in transactions with affiliates; and make certain investments. The Global Credit Facility also requires the Company to maintain a maximum ratio of Adjusted Debt to Consolidated EBITDAR (the "leverage ratio") of no greater than 4.25 as of the date of measurement for the four most recent consecutive fiscal quarters. Adjusted Debt is defined generally as consolidated debt outstanding, including finance lease obligations, plus all operating lease obligations. Consolidated EBITDAR is defined generally as consolidated net income plus (i) income tax expense, (ii) net interest expense, (iii) depreciation and amortization expense, (iv) operating lease cost, (v) restructuring and other non-recurring expenses, and (vi) acquisition-related costs. As of September 28, 2024 December 28, 2024, no Event of Default (as such term is defined pursuant to the Global Credit Facility) has occurred under the Company's Global Credit Facility.

Pan-Asia Borrowing Facilities

Certain of the Company's subsidiaries in Asia have uncommitted credit facilities with regional branches of JPMorgan Chase in China and South Korea (the "Pan-Asia Credit Facilities"). Additionally, the Company's Japan subsidiary has an uncommitted overdraft facility with Sumitomo Mitsui Banking Corporation (the "Japan Overdraft Facility"). The Pan-Asia Credit Facilities and Japan Overdraft Facility (collectively, the "Pan-Asia Borrowing Facilities") are subject to annual renewal and may be used to fund general working capital needs of the Company's operations in the respective countries. Borrowings under the Pan-Asia Borrowing Facilities are guaranteed by the parent company and are granted at the sole discretion of the respective banks, subject to availability of the banks' funds and satisfaction of certain regulatory requirements. The Pan-Asia Borrowing Facilities do not contain any financial covenants.

A summary of the Company's Pan-Asia Borrowing Facilities by country is as follows:

- China Credit Facility — provides Ralph Lauren Trading (Shanghai) Co., Ltd. with a revolving line of credit of up to 100 million Chinese Renminbi (approximately **\$14 million** **\$13 million**) through April 3, 2025, which is also able to be used to support bank guarantees.
- South Korea Credit Facility — provides Ralph Lauren (Korea) Ltd. with a revolving line of credit of up to 30 billion South Korean Won (approximately **\$22 million** **\$20 million**) through October 24, 2025.
- Japan Overdraft Facility — provides Ralph Lauren Corporation Japan with an overdraft amount of up to 5 billion Japanese Yen (approximately **\$35 million** **\$32 million**) through April 30, 2025.

As of both **September 28, 2024** **December 28, 2024** and March 30, 2024, there were no borrowings outstanding under the Pan-Asia Borrowing Facilities.

The fair values of the Company's commercial paper notes and borrowings outstanding under its credit facilities, if any, are estimated using external pricing data, based on interest rates and credit ratings for similar issuances with the same remaining term as the Company's outstanding borrowings. Non-financial Assets and Liabilities

The Company's non-financial assets, which primarily consist of goodwill, other intangible assets, property and equipment, and lease-related ROU assets, are not required to be measured at fair value on a recurring basis, and instead are reported at their amortized or depreciated cost in its consolidated balance sheet. However, on a periodic basis or whenever events or changes in circumstances indicate that they may not be fully recoverable (and at least annually for goodwill and indefinite-lived intangible assets), the respective carrying value of non-financial assets are assessed for impairment and, if ultimately considered impaired, are adjusted and written down to their fair value, as estimated based on consideration of external market participant assumptions and discounted cash flows. No impairment charges were recorded during either of the three-month and six-month nine-month periods ended September 28, 2024 December 28, 2024 or September 30, 2023 December 30, 2023.

The Company performed its annual goodwill assessment using a qualitative approach as of the beginning of the second quarter of Fiscal 2025. In performing the assessment, the Company identified and considered the significance of relevant key factors, events, and circumstances that affected the fair values and/or carrying amounts of its reporting units with allocated goodwill. These factors included external factors such as macroeconomic, industry, and market conditions, as well as entity-specific factors, such as the Company's actual and expected financial performance. Additionally, the Company also considered the results of its most recent quantitative goodwill impairment test, which was performed as of the beginning of the second quarter of Fiscal 2024, the results of which indicated that the fair values of these reporting units significantly exceeded their respective carrying values. Based on the results of the qualitative impairment assessment, the Company concluded that it is not more likely than not that the fair values of its reporting units are less than their respective carrying values and there were no reporting units at risk of impairment. No impairment charges associated with goodwill or other intangible assets were recorded during either of the six-month nine-month periods ended September 28, 2024 December 28, 2024 or September 30, 2023 December 30, 2023.

16. Segment Information

The Company has three reportable segments based on its business activities and organization:

- *North America* — The North America segment primarily consists of sales of Ralph Lauren branded apparel, footwear & accessories, home, and related products made through the Company's retail and wholesale businesses primarily in the U.S. and Canada. In North America, the Company's retail business is primarily comprised of its Ralph Lauren stores, its outlet stores, and its digital commerce sites, www.RalphLauren.com and www.RalphLauren.ca. The Company's wholesale business in North America is comprised primarily of sales to department stores and, to a lesser extent, specialty stores.
- *Europe* — The Europe segment primarily consists of sales of Ralph Lauren branded apparel, footwear & accessories, home, and related products made through the Company's retail and wholesale businesses in Europe and emerging markets. In Europe, the Company's retail business is primarily comprised of its Ralph Lauren stores, its outlet stores, its concession-based shop-within-shops, and its various digital commerce sites. The Company's wholesale business in Europe is comprised primarily of a varying mix of sales to both department stores and specialty stores, depending on the country, as well as to various third-party digital and licensee partners.
- *Asia* — The Asia segment primarily consists of sales of Ralph Lauren branded apparel, footwear & accessories, home, and related products made through the Company's retail and wholesale businesses in Asia, Australia, and New Zealand. The Company's retail business in Asia is primarily comprised of its Ralph Lauren stores, its outlet stores, its concession-based shop-within-shops, and its various digital commerce sites. In addition, the Company sells its products online through various third-party digital partner commerce sites. The Company's wholesale business in Asia is comprised primarily of sales to department stores and various third-party digital and licensee partners.

No operating segments were aggregated to form the Company's reportable segments. In addition to these reportable segments, the Company also has other non-reportable segments, which primarily consist of Ralph Lauren and Chaps branded royalty revenues earned through its global licensing alliances.

The Company's segment reporting structure is consistent with how it establishes its overall business strategy, allocates resources, and assesses performance of its business. The accounting policies of the Company's segments are consistent with those described in Notes 2 and 3 of the Fiscal 2024 10-K. Sales and transfers between segments are generally recorded at cost and treated as transfers of inventory. All intercompany revenues are eliminated in consolidation and are not reviewed when evaluating segment performance. Each segment's performance is evaluated based upon net revenues and operating income before restructuring-related charges, impairment of assets, and certain other one-time items, if any. Certain corporate overhead expenses related to global functions, most notably the Company's executive office, information technology, finance and accounting, human resources, and legal departments, largely remain at corporate. Additionally, other costs that cannot be allocated to the segments based on specific usage are also maintained at corporate, including corporate marketing and advertising expenses, depreciation and amortization of corporate assets, and other general and administrative expenses resulting from corporate-level activities and projects.

OVERVIEW

Our Business

Our Company is a global leader in the design, marketing, and distribution of luxury lifestyle products, including apparel, footwear & accessories, home, fragrances, and hospitality. Our long-standing reputation and distinctive image have been developed across a wide range of products, brands, distribution channels, and international markets. Our brand names include Ralph Lauren, Ralph Lauren Collection, Ralph Lauren Purple Label, Double RL, Polo Ralph Lauren, Lauren Ralph Lauren, Polo Ralph Lauren Children, and Chaps, among others.

We diversify our business by geography (North America, Europe, and Asia, among other regions) and channel of distribution (retail, wholesale, and licensing). This allows us to maintain a dynamic balance as our operating results do not depend solely on the performance of any single geographic area or channel of distribution. We sell directly to consumers through our integrated retail channel, which includes our retail stores, concession-based shop-within-shops, and digital commerce operations around the world. Our wholesale sales are made principally to major department stores, specialty stores, and third-party digital partners around the world, as well as to certain third-party-owned stores to which we have licensed the right to operate in defined geographic territories using our trademarks. In addition, we license to third parties for specified periods the right to access our various trademarks in connection with the licensees' manufacture and sale of designated products, such as certain apparel, eyewear, fragrances, and home furnishings.

We organize our business into the following three reportable segments:

- *North America* — Our North America segment, representing approximately 44% of our Fiscal 2024 net revenues, primarily consists of sales of our Ralph Lauren branded products made through our retail and wholesale businesses primarily in the U.S. and Canada. In North America, our retail business is primarily comprised of our Ralph Lauren stores, our outlet stores, and our digital commerce sites, www.RalphLauren.com and www.RalphLauren.ca. Our wholesale business in North America is comprised primarily of sales to department stores and, to a lesser extent, specialty stores.
- *Europe* — Our Europe segment, representing approximately 30% of our Fiscal 2024 net revenues, primarily consists of sales of our Ralph Lauren branded products made through our retail and wholesale businesses in Europe and emerging markets. In Europe, our retail business is primarily comprised of our Ralph Lauren stores, our outlet stores, our concession-based shop-within-shops, and our various digital commerce sites. Our wholesale business in Europe is comprised primarily of a varying mix of sales to both department stores and specialty stores, depending on the country, as well as to various third-party digital and licensee partners.
- *Asia* — Our Asia segment, representing approximately 24% of our Fiscal 2024 net revenues, primarily consists of sales of our Ralph Lauren branded products made through our retail and wholesale businesses in Asia, Australia, and New Zealand. Our retail business in Asia is primarily comprised of our Ralph Lauren stores, our outlet stores, our concession-based shop-within-shops, and our various digital commerce sites. In addition, we sell our products online through various third-party digital partner commerce sites. Our wholesale business in Asia is comprised primarily of sales to department stores and various third-party digital and licensee partners.

No operating segments were aggregated to form our reportable segments. In addition to these reportable segments, we also have other non-reportable segments, representing approximately 2% of our Fiscal 2024 net revenues, which primarily consist of Ralph Lauren and Chaps branded royalty revenues earned through our global licensing alliances.

Approximately 55% of our Fiscal 2024 net revenues were earned outside of the U.S. See Note 16 to the accompanying consolidated financial statements for further discussion of our segment reporting structure.

Our business is typically affected by seasonal trends, with higher levels of retail sales in our second and third fiscal quarters and higher wholesale sales in our second and fourth fiscal quarters. These trends result primarily from the timing of key vacation travel, back-to-school, and holiday shopping periods impacting our retail business and timing of seasonal wholesale shipments. As a result of changes in our business, consumer spending patterns, and the macroeconomic environment, including those resulting from pandemic diseases and other catastrophic events, historical quarterly operating trends and working capital requirements may not be indicative of our future performance. In addition, fluctuations in sales, operating income (loss), and cash flows in any fiscal quarter may be affected by other events affecting retail sales, such as changes in weather patterns. Accordingly, our operating results and cash flows for the three-month and ~~six-month~~ ~~nine-month~~ periods ended ~~September 28, 2024~~ ~~December 28, 2024~~ are not necessarily indicative of the operating results and cash flows that may be expected for the full Fiscal 2025.

Recent Developments

Next Generation Transformation Project

We are in the early stages of executing a large-scale, multi-year global project that is expected to significantly transform the way in which we operate our business and further enable our long-term strategic pivot towards a global direct-to-consumer-oriented model (the "Next Generation Transformation project" or "NGT project"). The NGT project will be completed in phases and involves the redesigning of certain end-to-end processes and the implementation of a suite of information systems on a global scale. Such efforts are expected to result in significant process improvements and the creation of synergies across core areas of operations, including merchandise buying and planning, procurement, inventory management, retail and wholesale operations, and financial planning and reporting, better enabling us to optimize inventory levels and increase the speed with which we react to changes in consumer demand across markets, among other benefits.

In connection with the preliminary phase of the NGT project, we incurred other charges of ~~\$5.7 million~~ ~~\$9.1 million~~ and ~~\$8.0 million~~ ~~\$17.1 million~~ during the three-month and ~~six-month~~ ~~nine-month~~ periods ended ~~September 28, 2024~~ ~~December 28, 2024~~, respectively, which were recorded within restructuring and other charges, net in the consolidated statements of operations.

Global Economic Conditions and Industry Trends

The global economy and retail industry are impacted by many different factors. Changes in economic conditions, most notably persisting inflationary pressures (including increases in the cost of raw materials, transportation, and salaries & benefits), organized labor disputes, high interest rates, significant foreign currency volatility, bank failures, and concerns of a potential recession, continue to impact consumer discretionary income levels, spending, and sentiment in the U.S. and beyond. In response to such pressures, as well as in an effort to reduce elevated inventory levels, many retailers (particularly in the U.S.) continue to resort to promotional activity in an attempt to offset traffic declines and increase conversion. Furthermore, the department store sector has experienced numerous consolidations, restructurings, reorganizations, bankruptcies, and other ownership changes in recent times, as well as an increase in store closures. The future geopolitical landscape also remains particularly uncertain, ~~with as~~ over 60 countries ~~holding held~~ national elections during 2024, including the recent U.S. presidential election. Any resulting changes in international trade relations, legislation and regulations (including those related to taxation, ~~tariffs~~, and importation), or economic and monetary policies, or heightened diplomatic tensions or political and civil unrest, among other potential impacts, could adversely impact the global economy and our operating results.

~~The global supply chain also continues to be negatively impacted by various factors, including the recent port strikes on the U.S. East and Gulf Coasts and ongoing disruptions in the Red Sea. Although our business has not been significantly impacted by such disruptions, we have experienced some shipping delays impacting the timing of inventory receipts, and the continuation of such disruptions over a prolonged period could result in further inventory receipt delays and/or higher freight costs in the near-term and beyond.~~

The global economy has also been negatively impacted by ongoing military conflicts taking place in various parts of the world, most notably the Russia-Ukraine and Israel-Hamas wars, other recent hostilities in the Middle East, and militant attacks on cargo vessels in the Red Sea. Although our voluntary decision to suspend operations in Russia has not resulted in a material impact to our consolidated financial statements and our ongoing operations in Israel are also not material, our business has been, and may continue to be, impacted by the broader macroeconomic implications resulting from these and other military conflicts, including inflationary pressures, unfavorable foreign currency exchange rates, increases in energy prices, food shortages, and volatility in financial markets, among other factors, which have adversely impacted consumer sentiment and

confidence. It is not clear at this time how long these conflicts will endure, or if they will escalate further with additional countries declaring war against each other, which could further amplify the impacts of the various macroeconomic factors described above and potentially result in a global recession.

~~The global supply chain has been negatively impacted by various factors, including disruptions at U.S. ports and in the Red Sea. Although our business has not been significantly impacted by such disruptions, we have experienced some shipping delays impacting the timing of inventory receipts, and if such disruptions were to continue over a~~

prolonged period, it could result in further inventory receipt delays and/or higher freight costs in the near-term and beyond.

We have implemented various strategies globally to help address many of these current challenges and continue to build a foundation for long-term profitable growth centered around strengthening our consumer-facing areas of product, stores, and marketing across channels and driving a more efficient operating model. Our strategy for mitigating inflationary pressures includes numerous levers, including our commitment ability to driving average unit retail growth, effectively increase prices, leveraging our diversified supply chain and strong supplier relationships, elevating our product sustainability efforts, and leveraging our in-house quality control to reduce time and cost from the manufacturing process, among other efforts. We have also taken earlier receipts of inventory and strategically utilized faster means of transportation (i.e., air freight) when necessary to maximize full-price selling windows, as well as diverted certain near-term shipments to U.S. West Coast ports to mitigate risk should strikes had a labor agreement on the East and Gulf Coasts resume on not been reached by the January 15, 2025, deadline. While we remain agile and mindful of the increasingly continued competitive promotional environment, we plan to continue driving our broader long-term strategy of brand elevation, which includes multiple levers to continue driving average unit retail growth and brand equity.

We will continue to monitor these conditions and trends and will evaluate and adjust our operating strategies and foreign currency and cost management opportunities to help mitigate the related impacts on our results of operations, while remaining focused on the long-term growth of our business and protecting and elevating the value of our brand.

Summary of Financial Performance

Operating Results

During the three months ended September 28, 2024 December 28, 2024, we reported net revenues of \$1.726 billion \$2.143 billion, net income of \$147.9 million \$297.4 million, and net income per diluted share of \$2.31, \$4.66, as compared to net revenues of \$1.633 billion \$1.934 billion, net income of \$146.9 million \$276.6 million, and net income per diluted share of \$2.19 \$4.19 during the three months ended September 30, 2023 December 30, 2023. During the six nine months ended September 28, 2024 December 28, 2024, we reported net revenues of \$3.238 billion \$5.382 billion, net income of \$316.5 million \$613.9 million, and net income per diluted share of \$4.93, \$9.57, as compared to net revenues of \$3.130 billion \$5.063 billion, net income of \$279.0 million \$555.6 million, and net income per diluted share of \$4.15 \$8.31 during the six nine months ended September 30, 2023 December 30, 2023. The comparability of our operating results has been affected by net restructuring-related charges and certain other charges (benefits). We have also continue to experience experienced varying degrees of business disruptions resulting from the current macroeconomic environment, including global supply chain disruptions, resulting from organized labor disputes, inflationary pressures, ongoing military conflicts taking place in various parts of the world, and foreign currency volatility, among other factors.

Our operating performance for the three-month and six-month nine-month periods ended September 28, 2024 December 28, 2024 as compared to the prior fiscal year periods reflected revenue increases of 5.7% 10.8% and 3.5% 6.3%, respectively, on a reported basis and 5.6% 11.2% and 4.3% 6.9%, respectively, on a constant currency basis, as defined within "Transactions and Trends Affecting Comparability of Results of Operations and Financial Condition" below. Net revenue revenues reflected growth was led by across all of our direct-to-consumer channels and international businesses, reportable segments.

Our gross profit as a percentage of net revenues increased by 150 190 basis points to 67.0% 68.4% during the three months ended September 28, 2024 December 28, 2024 and by 140 160 basis points to 68.6% 68.5% during the six nine months ended September 28, 2024 December 28, 2024, as compared to the prior fiscal year periods, primarily driven by favorable product, channel, and geographic mix, shifts, lower cotton costs, and average unit retail ("AUR") growth, partially offset by higher freight and other non-freight-related product costs.

Selling, general, and administrative ("SG&A") expenses as a percentage of net revenues during the three months ended September 28, 2024 increased December 28, 2024 declined by 60 30 basis points to 55.5% and by 60 basis points to 55.8% during the six months ended September 28, 2024 49.7% as compared to the prior fiscal year periods, period, largely attributable to operating leverage on higher net revenues and our operational discipline, which more than offset increases across various expense categories, including compensation-related expenses, and geographic and channel mix resulting from growth of our international and retail businesses which typically carry higher operating expense margins, margins. During the nine months ended December 28, 2024, SG&A expenses as a percentage of net revenues increased by 20 basis points to 53.4% as compared to the prior fiscal year period, largely attributable to geographic and channel mix, as well as increases across various expense categories, including higher marketing investments due to the planned timing of key campaign events, events and higher compensation-related expenses.

Net income increased by \$20.8 million to \$297.4 million during the three months ended December 28, 2024 as compared to the three months ended December 30, 2023, primarily due to a \$72.0 million increase in our operating income, partially offset by a \$33.1 million increase in our income tax provision and an \$18.1 million increase in non-operating expense, net. Net income per diluted share increased by \$0.47 to \$4.66 per share during the three months ended December 28, 2024 as compared

Net income increased by \$1.0 million to \$147.9 million during the three months ended September 28, 2024 as compared to the three months ended September 30, 2023 December 30, 2023, primarily driven by the higher level of net income and lower weighted-average diluted shares outstanding. Net income increased by \$58.3 million to \$613.9 million during the nine months ended December 28, 2024 as compared to the nine months ended December 30, 2023, primarily due to a \$14.4 million \$128.5 million increase in our operating income, and an \$8.2 million increase in non-operating income, net, partially offset by a \$21.6 million \$64.2 million increase in our income tax provision. Net income per diluted share increased by \$0.12 \$1.26 to \$2.31 \$9.57 per share during the three nine months ended September 28, 2024 December 28, 2024 as compared to the three nine months ended September 30, 2023, primarily driven by lower weighted-average diluted shares outstanding and the higher level of net income. Net income increased by \$37.5 million to \$316.5 million during the six months ended September 28, 2024 as compared to the six months ended September 30, 2023, primarily due to a \$56.5 million increase in our operating income and a \$12.1 million increase in our non-operating income, net, partially offset by a \$31.1 million increase in our income tax provision. Net income per diluted share increased by \$0.78 to \$4.93 per share during the six months ended September 28, 2024 as compared to the six months ended September 30, 2023 December 30, 2023, driven by the higher level of net income and lower weighted-average diluted shares outstanding.

Our operating results during each of the three-month periods three months ended September 28, 2024 and September 30, 2023, December 28, 2024 were negatively impacted by net restructuring-related charges and certain other charges (benefits) totaling \$18.4 million and \$7.2 million of \$12.2 million, respectively, which had an after-tax effect of reducing net income by \$14.2 million \$10.5 million, or \$0.23 \$0.16 per diluted share, share. During the three months ended December 30, 2023, our operating results were favorably impacted by net restructuring-related charges and \$5.8 million certain other charges (benefits) of \$0.2 million, which had an after-tax effect of increasing net income by \$1.5 million, or \$0.09 \$0.02 per diluted share, respectively, share. During the six-month nine-month periods ended September 28, 2024 December 28, 2024 and September 30, 2023 December 30, 2023, our operating results were negatively impacted by net restructuring-related charges and certain other charges (benefits) totaling \$25.8 million \$38.0 million and \$40.9 million \$40.7 million, respectively, which had an after-tax effect of reducing net income by \$20.2 million \$30.7 million, or \$0.31 \$0.48 per diluted share, and \$31.7 million \$30.2 million, or \$0.46 \$0.45 per diluted share, respectively. Net income during both the three-month and six-month periods nine months ended September 30, 2023 December 30, 2023 also reflected an income tax benefit of \$11.8 million, or \$0.18 and \$0.17 per diluted share, respectively, recorded in connection with non-recurring income tax events.

Financial Condition and Liquidity

We ended the second third quarter of Fiscal 2025 in a net cash and short-term investments position (calculated as cash and cash equivalents, plus short-term investments, less total debt) of \$548.2 million \$1.001 billion, as compared to \$642.7 million as of the end of Fiscal 2024. The decrease increase in our net cash and short-term investments position was primarily due to our operating cash flows of \$1.113 billion, partially offset by our use of cash to support Class A common stock repurchases of \$330.2 million \$404.6 million, including withholdings in satisfaction of tax obligations for stock-based compensation awards, to make dividend payments of \$98.9 million \$150.1 million, and to invest in our business through \$75.1 million \$136.3 million in capital expenditures, partially offset by our operating cash flows of \$374.5 million and the favorable unfavorable effect of exchange rate changes of \$36.8 million \$40.9 million primarily related to our cash and cash equivalents.

Net cash provided by operating activities was \$374.5 million \$1.113 billion during the six nine months ended September 28, 2024 December 28, 2024, as compared to \$343.6 million \$948.7 million during the six nine months ended September 30, 2023 December 30, 2023. The net increase in cash provided by operating activities was due to an increase in net income before non-cash charges, partially offset by as well as a net unfavorable favorable change related to our operating assets and liabilities, including our working capital, as compared to the prior fiscal year period.

Our equity decreased increased to \$2.442 billion \$2.539 billion as of September 28, 2024 December 28, 2024 compared to \$2.450 billion as of March 30, 2024 due to our share repurchase activity and dividends declared during the six months ended September 28, 2024, partially offset by our comprehensive income and the net impact of stock-based compensation arrangements. arrangements, partially offset by our share repurchase activity and dividends declared during the nine months ended December 28, 2024.

Because we are a global company, the comparability of our operating results reported in U.S. Dollars is also affected by foreign currency exchange rate fluctuations because the underlying currencies in which we transact change in value over time compared to the U.S. Dollar. Such fluctuations can have a significant effect on our reported results. As such, in addition to financial measures prepared in accordance with accounting principles generally accepted in the U.S. ("U.S. GAAP"), our discussions often contain references to constant currency measures, which are calculated by translating current-year and prior-year reported amounts into comparable amounts using a single foreign exchange rate for each currency. We present constant currency financial information, which is a non-U.S. GAAP financial measure, as a supplement to our reported operating results. We use constant currency information to provide a framework for assessing how our businesses performed excluding the effects of foreign currency exchange rate fluctuations. We believe this information is useful to investors for facilitating comparisons of operating results and better identifying trends in our businesses. The constant currency performance measures should be viewed in addition to, and not in lieu of or superior to, our operating performance measures calculated in accordance with U.S. GAAP. Reconciliations between this non-U.S. GAAP financial measure and the most directly comparable U.S. GAAP measure are included in the "Results of Operations" section where applicable.

Our discussion also includes reference to comparable store sales. Comparable store sales refer to the change in sales of our stores that have been open for at least 13 full fiscal months. Sales from our digital commerce sites are also included within comparable sales for those geographies that have been serviced by the related site for at least 13 full fiscal months. Sales for stores or digital commerce sites that are closed or shut down during the year are excluded from the calculation of comparable store sales. Sales for stores that are either relocated, enlarged (as defined by gross square footage expansion of 25% or greater), or generally closed for 30 or more consecutive days for renovation are also excluded from the calculation of comparable store sales until such stores have been operating in their new location or in their newly renovated state for at least 13 full fiscal months. All comparable store sales metrics are calculated on a constant currency basis.

Our "Results of Operations" discussion that follows includes the significant changes in operating results arising from these items affecting comparability. However, unusual items or transactions may occur in any period. Accordingly, investors and other financial statement users should consider the types of events and transactions that have affected operating trends.

Net Revenues. Net revenues increased by \$93.0 million\$209.5 million, or 5.7%10.8%, to \$1.726 billion\$2.143 billion during the three months ended September 28, 2024December 28, 2024 as compared to the three months ended September 30, 2023December 30, 2023, reflecting growth across all of our reportable segments. segments, partially offset by unfavorable foreign currency effects of \$6.9 million. On a constant currency basis, net revenues increased by \$92.2 million\$216.4 million, or 5.6%11.2%.

North America net revenues — Net revenues increased by \$21.7 million \$64.4 million, or 3.0% 6.9%, during the three months ended September 28, 2024 December 28, 2024 as compared to the three months ended September 30, 2023 December 30, 2023. On a constant currency basis, net revenues increased by \$22.1 million \$65.9 million, or 3.1% 7.1%.

The \$21.7 million \$64.4 million increase in North America net revenues was driven by:

- a \$29.5 million \$50.5 million increase related to our North America retail business. On a constant currency basis, net revenues increased by \$29.8 million \$51.8 million, reflecting increases an increase of \$25.4 million \$53.5 million in comparable store sales, and \$4.4 million partially offset by a decrease of \$1.7 million in non-comparable store sales. The following table summarizes the percentage change changes in comparable store sales related to our North America retail business:

- a \$13.9 million increase related to our North America wholesale business primarily driven by improved Fall sell-out trends and strong replenishment orders.

This increase was partially offset by a \$7.8 million decline related to our North America wholesale business primarily driven by planned reductions in excess product sales within the off-price wholesale channel.

Europe net revenues — Net revenues increased by \$39.1 million \$82.9 million, or 7.4% 15.9%, during the three months ended September 28, 2024 December 28, 2024 as compared to the three months ended September 30, 2023 December 30, 2023. On a constant currency basis, net revenues increased by \$33.4 million \$81.4 million, or 6.3% 15.6%.

The \$39.1 million \$82.9 million increase in Europe net revenues was driven by:

- a \$34.5 million \$50.4 million increase related to our Europe retail business, inclusive of favorable foreign currency effects of \$2.6 million \$0.3 million. On a constant currency basis, net revenues increased by \$31.9 million \$50.1 million, primarily driven by an increase reflecting increases of \$32.0 million \$49.5 million in comparable store sales and \$0.6 million in non-comparable store sales. - a \$4.6 million \$32.5 million increase related to our Europe wholesale business largely driven by favorable foreign currency effects of \$3.1 million and stronger re-order trends more than offsetting and a timing shift of inventory receipts from the second quarter of Fiscal 2025 into the second half of third quarter, which more than offset planned reductions within the fiscal year. off-price wholesale channel.

Asia net revenues — Net revenues increased by \$31.8 million \$60.3 million, or 9.1% 13.5%, during the three months ended September 28, 2024 December 28, 2024 as compared to the three months ended September 30, 2023 December 30, 2023. On a constant currency basis, net revenues increased by \$36.3 million \$67.1 million, or 10.4% 15.0%.

The \$31.8 million \$60.3 million increase in Asia net revenues was driven by:

- a \$38.1 million \$65.1 million increase related to our Asia retail business, inclusive of unfavorable foreign currency effects of \$4.2 million \$7.0 million. On a constant currency basis, net revenues increased by \$42.3 million \$72.1 million, reflecting increases of \$29.4 million \$51.6 million in comparable store sales and \$12.9 million \$20.5 million in non-comparable store sales. This increase was partially offset by a \$6.3 million \$4.8 million decline related to our Asia wholesale business, inclusive of unfavorable foreign currency effects of \$0.3 million. largely driven by decreases in South Korea and Japan.

Gross Profit. Gross profit increased by \$85.6 million \$180.1 million, or 8.0% 14.0%, to \$1.156 billion \$1.466 billion for the three months ended September 28, 2024 December 28, 2024, including unfavorable foreign currency effects of \$2.3 million \$3.4 million. Gross profit as a percentage of net revenues increased to 67.0% 68.4% for the three months ended September 28, 2024 December 28, 2024 from 65.5% 66.5% for the three months ended September 30, 2023 December 30, 2023. The 150 190 basis point increase was primarily driven by favorable product, channel, and geographic mix, shifts, lower cotton costs, and AUR growth, partially offset by higher freight and other non-freight-related product costs.

Gross profit as a percentage of net revenues is dependent upon a variety of factors, including changes in the relative sales mix among distribution channels, changes in the mix of products sold, pricing, the timing and level of promotional activities, foreign currency exchange rates, and fluctuations in product costs. These factors, among others, may cause gross profit as a percentage of net revenues to fluctuate from period to period.

Selling, General, and Administrative Expenses. SG&A expenses include costs relating to compensation and benefits, marketing and advertising, rent and occupancy, distribution, information technology, legal, depreciation and amortization, bad debt, and other selling and administrative costs. SG&A expenses increased by \$62.1 million \$96.6 million, or 6.9% 10.0%, to \$958.4 million \$1.064 billion for the three months ended September 28, 2024 December 28, 2024, including unfavorable favorable foreign currency effects of \$1.5 million \$3.4 million. SG&A expenses as a percentage of net revenues increased declined to 55.5% 49.7% for the three months ended September 28, 2024 December 28, 2024 from 54.9% 50.0% for the three months ended September 30, 2023 December 30, 2023. The 60 30 basis point increase improvement was largely attributable to operating leverage on higher net revenues and our operational discipline, which more than offset increases across various expense categories, including compensation-related expenses, and geographic and channel mix resulting from growth of our international and retail businesses which typically carry higher operating expense margins, as well as increases across various expense categories, including higher marketing investments due to the planned timing of key campaign events. margins.

Restructuring and Other Charges, Net. During the three-month periods ended **September 28, 2024** **December 28, 2024** and **September 30, 2023** **December 30, 2023**, we recorded restructuring charges of **\$9.0 million** **\$1.6 million** and **\$6.8 million** **\$1.0 million**, respectively, as well as other charges of **\$4.1 million** **\$2.2 million** and **\$4.5 million** **\$4.7 million**, respectively, primarily related to rent and occupancy costs associated with certain previously exited real estate locations for which the related lease agreements have not yet expired. In addition, during the three months ended **September 28, 2024** **December 28, 2024**, we recorded other charges of **\$5.7 million** **\$9.1 million** in connection with our Next Generation Transformation project (refer to "Recent Developments" for additional discussion) and other income of **\$0.4 million** **\$0.7 million** and **\$2.0 million** **\$5.0 million** during the three-month periods ended **September 28, 2024** **December 28, 2024** and **September 30, 2023** **December 30, 2023**, respectively, related to consideration received from Regent, L.P. in connection with our previously sold Club Monaco business. See Note 7 to the accompanying consolidated financial statements.

Operating Income. Operating income increased by **\$14.4 million** **\$72.0 million**, or **8.8%** **22.6%**, to **\$178.9 million** **\$389.7 million** for the three months ended **September 28, 2024**, reflecting unfavorable foreign **December 28, 2024**. Foreign currency effects of **\$3.8 million** were inconsequential to operating income during the three months ended **December 28, 2024**. Our Additionally, our operating results during the three-month periods ended **September 28, 2024** and **September 30, 2023** were negatively impacted by included net restructuring-related charges and certain other charges (benefits) totaling **\$18.4 million**, which had an unfavorable impact of **\$12.2 million** during the three months ended **December 28, 2024** and **\$7.2 million**, respectively, a favorable impact of **\$0.2 million** during the three months ended **December 30, 2023**. Operating income as a percentage of net revenues was **10.4%** **18.2%** for the three months ended **September 28, 2024** **December 28, 2024**, reflecting a **30** **180** basis point increase from the prior fiscal year period. The increase in operating income as a percentage of net revenues was primarily driven by the increase in our gross margin, partially offset by as well as the increase decrease in SG&A expenses as a percentage of net revenues, as well as partially offset by the higher net restructuring-related charges and certain other charges (benefits) recorded during the three months ended **September 28, 2024** **December 28, 2024** as compared to the prior fiscal year period, all as previously discussed.

North America operating margin improved by 110 450 basis points, primarily due to the net favorable impact of approximately 170 460 basis points driven by an increase in gross margin and a decrease in SG&A expenses as a percentage of net revenues. This overall improvement in operating margin was partially offset by the unfavorable impact of approximately 30 basis points attributable to channel mix and the unfavorable impact of 30 10 basis points attributable to the absence of non-routine inventory benefits during the three months ended September 28, 2024 December 28, 2024 as compared to those recorded during the prior fiscal year period.

Europe operating margin improved by 70 420 basis points, primarily due to the net favorable impact of approximately 130 350 basis points driven by an increase in gross margin and a decrease in SG&A expenses as a percentage of net revenues. This overall improvement in operating margin was partially offset by the unfavorable impact of 40 basis points attributable to channel mix, as well as unfavorable also reflected favorable foreign currency effects of 20 70 basis points.

Asia operating margin improved by 310 270 basis points, primarily due to the net favorable impact of approximately 440 320 basis points driven by a decline in SG&A expenses as a percentage of net revenues and an increase in gross margin. This overall improvement in operating margin was partially offset by unfavorable foreign currency effects of 80 basis points and the unfavorable impact of approximately 50 basis points attributable to channel mix, points.

Unallocated corporate expenses increased by \$19.0 million \$49.7 million to \$190.3 million \$196.9 million during the three months ended September 28, 2024 December 28, 2024 as compared to the prior fiscal year. The increase in unallocated corporate expenses was due to higher compensation-related expenses of \$11.0 million \$26.5 million, lower intercompany sourcing commission of \$9.2 million (which is offset at the segment level and eliminates in consolidation), higher non-income taxes of \$9.0 million \$3.3 million, and higher marketing and advertising expenses of \$7.9 million, partially offset by lower rent and occupancy expenses of \$5.2 million and lower other expenses of \$3.7 million \$10.7 million.

Unallocated restructuring and other charges, net increased by \$9.1 million \$11.5 million to \$18.4 million \$12.2 million during the three months ended September 28, 2024 December 28, 2024, as previously discussed above and in Note 7 to the accompanying consolidated financial statements.

Non-operating Income (Expense), Net. Non-operating income (expense), net is comprised of interest expense, interest income, and other income (expense), net, which includes foreign currency gains (losses), equity in income (losses) from our equity-method investees, and other non-operating expenses. During the three months ended September 28, 2024 December 28, 2024, we reported non-operating expense, net, of \$6.0 million as compared to non-operating income, net, of \$9.2 million as compared to \$1.0 million \$12.1 million during the three months ended September 30, 2023 December 30, 2023. The \$8.2 million \$18.1 million increase in non-operating income, expense, net was mainly due to a \$7.5 million increase in other income (expense), net primarily driven by higher net foreign currency gains during the three months ended September 28, 2024 losses of \$7.9 million as compared to the prior fiscal year period. period and a \$6.4 million investment write-down recorded during the three months ended December 28, 2024.

Income Tax Provision. The income tax provision represents federal, foreign, state and local income taxes. Our effective tax rate will change from period to period based on various factors including, but not limited to, the geographic mix of earnings, the timing and amount of foreign dividends, enacted tax legislation, state and local taxes, tax audit findings and settlements, and the interaction of various global tax strategies.

The income tax provision and effective tax rate for the three months ended **September 28, 2024** **December 28, 2024** were **\$40.2 million** **\$86.3 million** and **21.4%** **22.5%**, respectively, as compared to **\$18.6 million** **\$53.2 million** and **11.2%** **16.1%**, respectively, for the three months ended **September 30, 2023** **December 30, 2023**. The **\$21.6 million** **\$33.1 million** increase in our income tax provision was primarily driven by the absence of a one-time tax benefit of \$11.8 million recorded during the second quarter of Fiscal 2024 **640 basis point increase** in connection with Swiss tax reform and the European Union's anti-tax avoidance directive, which lowered our prior fiscal year period effective tax rate, by **710 basis points**, as well as an increase in our pretax income. The increase in our effective tax rate was also primarily due to the absence of a prior fiscal year favorable deferred tax benefit recognized adjustment related to a transaction entered into as part of a result reorganization of tax rate changes enacted in the prior year period. Net Income. Net income increased to **\$147.9 million** **\$297.4 million** for the three months ended **September 28, 2024** **December 28, 2024**, from **\$146.9 million** **\$276.6 million** for the three months ended **September 30, 2023** **December 30, 2023**. The **\$1.0 million** **\$20.8 million** increase in net income was due to the increases in our operating income, and non-operating income, net, partially offset by an increase increases in our income tax provision and non-operating expense, net, all as previously discussed. Our Additionally, our operating results during the three-month periods three months ended **September 28, 2024** and **September 30, 2023** **December 28, 2024** were negatively impacted by net restructuring-related charges and certain other charges (benefits) of **\$18.4 million** and **\$7.2 million** **\$12.2 million**, respectively, which had an after-tax effect of reducing net income by **\$14.2 million** and **\$5.8 million**, respectively. Net income during **\$10.5 million**. During the three months ended **September 30, 2023** also reflected **December 30, 2023**, our operating results were favorably impacted by net restructuring-related charges and certain other charges (benefits) of **\$0.2 million**, which had an after-tax effect of increasing net income tax benefit of **\$11.8 million** recorded in connection with Swiss tax reform and the European Union's anti-tax avoidance directive, as previously discussed. by **\$1.5 million**.

Net Income per Diluted Share. Net income per diluted share increased to **\$2.31** **\$4.66** for the three months ended **September 28, 2024** **December 28, 2024**, from **\$2.19** **\$4.19** for the three months ended **September 30, 2023** **December 30, 2023**. The **\$0.12** **\$0.47** per share increase was primarily driven by the higher level of net income, as previously discussed, and lower weighted-average diluted shares outstanding during the three months ended **September 28, 2024** **December 28, 2024** driven by our share repurchases during the last twelve months, and the higher level of net income, as previously discussed. months. Net income per diluted share for the three-month periods ended **September 28, 2024** **December 28, 2024** and **September 30, 2023** **December 30, 2023** were also negatively impacted by **\$0.23** **\$0.16** per share and **\$0.09** favorably impacted by **\$0.02** per share, respectively, attributable to net restructuring-related charges and certain other charges (benefits), as previously discussed. Net income per diluted share during the three months ended **September 30, 2023** was also favorably impacted by **\$0.18** due to an income tax benefit recorded in connection with Swiss tax reform and the European Union's anti-tax avoidance directive, as previously discussed.

Net revenues increased by \$108.7 million \$318.2 million, or 3.5% 6.3%, to \$3.238 billion \$5.382 billion during the six nine months ended September 28, 2024 December 28, 2024 as compared to the six nine months ended September 30, 2023 December 30, 2023, driven by reflecting growth across all of our direct-to-consumer channels and international businesses, reportable segments, partially offset by unfavorable foreign currency effects of \$25.3 million \$32.2 million. On a constant currency basis, net revenues increased by \$134.0 million \$350.4 million, or 4.3% 6.9%.

North America net revenues — Net revenues decreased increased by \$1.8 million \$62.6 million, or 0.1% 2.7%, during the six nine months ended September 28, 2024 December 28, 2024 as compared to the six nine months ended September 30, 2023 December 30, 2023. On a constant currency basis, net revenues decreased increased by \$0.9 million \$65.0 million, or 0.1% 2.8%.

The \$1.8 million decline \$62.6 million increase in North America net revenues was driven by:

- a \$37.0 million decline related to our North America wholesale business primarily driven by planned reductions in excess product sales within the off-price wholesale channel.

This decline was partially offset by:

On a constant currency basis, net revenues increased by \$65.7 million \$147.1 million, or 6.7% 9.8%.

The \$67.7 million \$150.6 million increase in Europe net revenues was driven by:

- a \$52.9 \$103.3 million increase related to our Europe retail business, inclusive of favorable foreign currency effects of \$0.6 \$0.9 million. On a constant currency basis, net revenues increased by \$52.3 \$102.4 million, reflecting increases of \$50.3 million \$99.8 million in comparable store sales and \$2.0 million \$2.6 million in non-comparable store sales. Asia net revenues — Net revenues increased by \$45.2 million \$105.5 million, or 6.2% 9.0%, during the six nine months ended September 28, 2024 December 28, 2024 as compared to the six nine months ended September 30, 2023 December 30, 2023. On a constant currency basis, net revenues increased by \$71.6 million \$138.7 million, or 9.9% 11.8%.

The \$45.2 million \$105.5 million increase in Asia net revenues was driven by:

- a \$56.8 \$121.9 million increase related to our Asia retail business, inclusive of unfavorable foreign currency effects of \$24.9 \$31.9 million. Gross Profit. Gross profit increased by \$119.4 million \$299.5 million, or 5.7% 8.8%, to \$2.222 billion \$3.688 billion for the six nine months ended September 28, 2024 December 28, 2024, including unfavorable foreign currency effects of \$27.1 million \$30.5 million. Selling, General, and Administrative Expenses. SG&A expenses as a percentage of net revenues increased to 55.8% 53.4% for the six nine months ended September 28, 2024 December 28, 2024 from 55.2% 53.2% for the six nine months ended September 30, 2023 December 30, 2023. Restructuring and Other Charges, Net. During the six-month nine-month periods ended September 28, 2024 December 28, 2024 and September 30, 2023 December 30, 2023, we recorded net restructuring charges of \$12.3 million \$13.9 million and \$37.3 million \$38.3 million, respectively, primarily consisting of severance and benefits costs, as well as other charges of \$6.9 million \$9.1 million and \$9.6 million \$14.3 million, respectively, primarily related to rent and occupancy costs associated with certain previously exited real estate locations in connection with our restructuring activities for which the related lease agreements have not yet expired. In addition, during the six nine months ended September 28, 2024 December 28, 2024, we recorded other charges of \$8.0 million \$17.1 million in connection with our Next Generation Transformation project (refer to "Recent Developments" for additional discussion) and recorded other income of \$1.4 million \$2.1 million and \$2.0 million \$7.0 million during the six-month nine-month

Operating Income. Operating income increased by \$56.5 million \$128.5 million, or 17.1% 19.8%, to \$387.4 million \$777.1 million for the six nine months ended September 28, 2024 December 28, 2024, reflecting unfavorable foreign currency effects of \$14.8 million. Our operating results during the six-month nine-month periods ended September 28, 2024 December 28, 2024 and September 30, 2023 December 30, 2023 were negatively impacted by net restructuring-related charges and certain other charges (benefits) totaling \$25.8 million \$38.0 million and \$40.9 million \$40.7 million, respectively. Operating income as a percentage of net revenues was 12.0% 14.4% for the six nine months ended September 28, 2024 December 28, 2024, reflecting a 140 160 basis point increase from the prior fiscal year period. The increase in operating income as a percentage of net revenues was primarily driven by the increase in our gross margin, as well as lower net restructuring-related charges and certain other charges (benefits) recorded during the six nine months ended September 28, 2024 December 28, 2024 as compared to the prior fiscal year period, partially offset by the slight increase in SG&A expenses as a percentage of net revenues, all as previously discussed.

North America operating margin improved by 50 230 basis points, primarily due to the net favorable impact of approximately 100 250 basis points driven by an increase in gross margin, margin and a decrease in SG&A expense as a percentage of net revenues. This overall improvement in operating margin was partially offset by the unfavorable impact of approximately 30 basis points attributable to channel mix and the unfavorable impact of 20 basis points attributable to the absence of non-routine inventory benefits during the six nine months ended September 28, 2024 December 28, 2024 as compared to those recorded during the prior fiscal year period.

Europe operating margin improved by 200 280 basis points, primarily due to the net favorable impact of approximately 260 300 basis points driven by an increase in gross margin and a decrease in SG&A expenses as a percentage of net revenues. revenues, as well as favorable foreign currency effects of 10 basis points. This overall improvement in operating margin was partially offset by unfavorable foreign currency effects of 40 basis points, as well as the unfavorable impact of 20 basis points attributable to channel mix, mix, as well as the unfavorable impact of 10 basis points attributable to the absence of non-routine bad debt expense reversals during the nine months ended December 28, 2024 as compared to those recorded during the prior fiscal year period.

Asia operating margin improved by 280 basis points, primarily due to the net favorable impact of approximately 370 360 basis points largely driven by a decline in SG&A expenses as a percentage of net revenues and an increase in gross margin. This overall improvement in operating margin was partially offset by unfavorable foreign currency effects of 50 basis points and the unfavorable impact of approximately 40 30 basis points attributable to channel mix.

Unallocated corporate expenses increased by \$32.7 million \$82.4 million to \$351.6 million \$548.5 million during the six nine months ended September 28, 2024 December 28, 2024 as compared to the prior fiscal year. The increase in unallocated corporate expenses was due to higher compensation-related expenses of \$35.5 million, higher marketing and advertising expenses of \$15.8 million \$15.6 million, higher non-income taxes of \$12.1 million \$15.4 million, higher compensation-related expenses lower intercompany sourcing commission of \$9.0 million \$11.2 million (which is offset at the segment level and eliminates in consolidation), and higher other expenses of \$7.1 million \$17.4 million, partially offset by lower rent and occupancy expenses of \$11.3 million \$12.7 million.

Unallocated restructuring and other charges, net decreased by \$19.1 million to \$25.8 million during the six months ended September 28, 2024, as previously discussed above and in Note 7 to the accompanying consolidated financial statements.

Unallocated restructuring and other charges, net decreased by \$7.6 million to \$38.0 million during the nine months ended December 28, 2024, as previously discussed above and in Note 7 to the accompanying consolidated financial statements.

Non-operating Income (Expense), Net. During the **six** **nine** months ended **September 28, 2024** **December 28, 2024**, we reported non-operating income, net of **\$17.3 million** **\$11.3 million** as compared to **\$5.2 million** **\$17.3 million** during the **six** **nine** months ended **September 30, 2023** **December 30, 2023**. The **\$12.1 million increase** **\$6.0 million net decrease** in non-operating income, net was **mainly driven by:**

- a **\$7.9 million increase** in other income (expense), net primarily driven by **higher net foreign currency gains** **an investment write-down recorded** during the **six** **nine** months ended **September 28, 2024** as compared to the prior fiscal year period; and
- a **\$6.5 million increase** in interest income driven by the higher average on-hand cash, cash equivalents, and short-term investments balance during the current fiscal year period as compared to the prior fiscal year period and higher interest rates in financial markets. **December 28, 2024.**

Income Tax Provision. The income tax provision and effective tax rate for the **six** **nine** months ended **September 28, 2024** **December 28, 2024** were **\$88.2 million** **\$174.5 million** and **21.8%** **22.1%**, respectively, compared to **\$57.1 million** **\$110.3 million** and **17.0%** **16.6%**, respectively, for the **six** **nine** months ended **September 30, 2023** **December 30, 2023**. The **\$31.1 million** **\$64.2 million** increase in our income tax provision was primarily driven by **an increase in our pretax income**, as well as a 550 basis point increase in our effective tax rate. The increase in our effective tax rate was due to the absence of prior year favorable adjustments related to the accrual of deferred tax assets in connection with a transaction entered into as part of a reorganization of the Company's corporate entity structure, and revaluation of deferred tax assets as a result of tax rate changes enacted in the prior year period, partially offset by a current year favorable adjustment related to the revaluation of a deferred tax liability on foreign earnings. The increase in our effective tax rate was also due to the absence of a one-time tax benefit of \$11.8 million recorded during the second quarter of Fiscal 2024 in connection with Swiss tax reform and the European Union's anti-tax avoidance directive, which lowered our prior fiscal year period effective tax rate by **350** **170** basis points, as well as an increase in our pretax income. The increase in our effective tax rate was also due to the absence of a prior year deferred tax benefit recognized as a result of tax rate changes enacted in the prior year period. **points.** See Note 8 to the accompanying consolidated financial statements.

Net Income. Net income increased to **\$316.5 million** **\$613.9 million** for the **six** **nine** months ended **September 28, 2024** **December 28, 2024**, from **\$279.0 million** **\$555.6 million** for the **six** **nine** months ended **September 30, 2023** **December 30, 2023**. The **\$37.5 million** **\$58.3 million** increase in net income was primarily due to the **increases** **increase** in our operating income, **and non-operating income, net**, partially offset by an increase in our income tax provision, **all both** as previously discussed. Our operating results during the **six-** **month** **nine-month** periods ended **September 28, 2024** **December 28, 2024** and **September 30, 2023** **December 30, 2023** were negatively impacted by net restructuring-related charges and certain other charges (benefits) totaling **\$25.8 million** **\$38.0 million** and **\$40.9 million** **\$40.7 million**, respectively, which had an after-tax effect of reducing net income by **\$20.2 million** **\$30.7 million** and **\$31.7 million** **\$30.2 million**, respectively. Net income during the **six** **nine** months ended **September 30, 2023** **December 30, 2023** also reflected an income tax benefit of \$11.8 million recorded in connection with Swiss tax reform and the European Union's anti-tax avoidance directive, as previously discussed.

Net Income per Diluted Share. Net income per diluted share increased to **\$4.93** **\$9.57** for the **six** **nine** months ended **September 28, 2024** **December 28, 2024**, from **\$4.15** **\$8.31** for the **six** **nine** months ended **September 30, 2023** **December 30, 2023**. The **\$0.78** **\$1.26** per share increase was primarily driven by the higher level of net income, as previously discussed, and lower weighted-average diluted shares outstanding during the **six** **nine** months ended **September 28, 2024** **December 28, 2024** driven by our share repurchases during the last twelve months. Net income per diluted share for the **six-month** **nine-month** periods ended **September 28, 2024** **December 28, 2024** and **September 30, 2023** **December 30, 2023** were also negatively impacted by **\$0.31** **\$0.48** per share and **\$0.46** **\$0.45** per share, respectively, attributable to net restructuring-related charges and certain other charges (benefits), as previously discussed. Net income per diluted share during the **six** **nine** months ended **September 30, 2023** **December 30, 2023** was also favorably impacted by **\$0.17** **\$0.18** due to an income tax benefit recorded in connection with Swiss tax reform and the European Union's anti-tax avoidance directive, as previously discussed.

The decrease/increase in our net cash and short-term investments position at September 28, 2024/December 28, 2024 as compared to March 30, 2024 was primarily due to our operating cash flows of \$1.113 billion, partially offset by our use of cash to support Class A common stock repurchases of \$330.2 million/\$404.6 million, including withholdings in satisfaction of tax obligations for stock-based compensation awards, to make dividend payments of \$98.9 million/\$150.1 million, and to invest in our business through \$75.1 million/\$136.3 million in capital expenditures, partially offset by our operating cash flows of \$374.5 million and the favorable/unfavorable effect of exchange rate changes of \$36.8 million/\$40.9 million primarily related to our cash and cash equivalents.

The decrease/increase in our equity was attributable to our share repurchase activity and dividends declared during the six months ended September 28, 2024, partially offset by our comprehensive income and the net impact of stock-based compensation arrangements. arrangements, partially offset by our share repurchase activity and dividends declared during the nine months ended December 28, 2024.

Net Cash Provided by Operating Activities. Net cash provided by operating activities was \$374.5 million/\$1.113 billion during the six/nine months ended September 28, 2024/December 28, 2024, as compared to \$343.6 million/\$948.7 million during the six/nine months ended September 30, 2023/December 30, 2023. The \$30.9 million/\$164.2 million net increase in cash provided by operating activities was due to an increase in net income before non-cash charges, partially offset by as well as a net unfavorable/favorable change related to our operating assets and liabilities, including our working capital, as compared to the prior fiscal year period.

The net unfavorable/favorable change related to our operating assets and liabilities, including our working capital, was primarily driven by:

- an unfavorable change in inventory driven by higher in-transit inventory, as well as higher product and freight costs; and

- an unfavorable change related to our accounts receivable, largely driven by a decline in wholesale net revenues and timing of cash receipts.

These decreases related to our operating assets and liabilities were partially offset by:

- a favorable change in our accounts payable driven by the timing of cash payments, as well as a net favorable change in accrued liabilities largely driven by the timing of accrued inventory and accrued marketing payroll and advertising projects, benefits resulting from anticipated higher bonus achievement levels, partially offset by our restructuring reserve due to a

decrease in restructuring charges recorded during the current fiscal year period as compared to the prior fiscal year period.

This increase related to our operating assets and liabilities was partially offset by:

- an unfavorable change in inventory driven by higher in-transit inventory, as well as higher product and freight costs.

Net Cash Used in Investing Activities. Net cash used in investing activities was \$279.8 million \$224.4 million during the six nine months ended September 28, 2024 December 28, 2024, as compared to \$132.9 million \$204.2 million during the six nine months ended September 30, 2023 December 30, 2023. The \$146.9 million \$20.2 million net increase in cash used in investing activities was primarily driven by:

- a \$155.2 million an \$11.4 million increase in capital expenditures. During the nine months ended December 28, 2024, we spent \$136.3 million on capital expenditures, as compared to \$124.9 million during the nine months ended December 30, 2023. Our capital expenditures during the nine months ended December 28, 2024 primarily related to store openings and renovations, as well as enhancements to our information technology systems; and
- an \$11.0 million increase in purchases of investments, less proceeds from sales and maturities of investments. During the six nine months ended September 28, 2024 December 28, 2024, we made net investment purchases of \$205.7 million \$89.3 million, as compared to \$50.5 million \$78.3 million during the six nine months ended September 30, 2023 December 30, 2023.

This increase in cash used in investing activities was partially offset by:

- a \$7.3 million decrease in capital expenditures. During the six months ended September 28, 2024, we spent \$75.1 million on capital expenditures, as compared to \$82.4 million during the six months ended September 30, 2023. Our capital expenditures during the six months ended September 28, 2024 primarily related to store openings and renovations, as well as enhancements to our information technology systems.

Over the course of Fiscal 2025, we expect to spend approximately \$250 million \$200 million to \$300 million \$250 million on capital expenditures primarily related to store opening and renovations, as well as enhancements to our information technology systems and corporate office renovations.

Net Cash Used in Financing Activities. Net cash used in financing activities was \$439.9 million \$571.2 million during the six nine months ended September 28, 2024 December 28, 2024, as compared to \$335.1 million \$491.8 million during the six nine months ended September 30, 2023 December 30, 2023. The \$104.8 million \$79.4 million net increase in cash used in financing activities was primarily driven by:

- a \$104.5 million \$75.8 million increase in cash used to repurchase shares of our Class A common stock. During the six nine months ended September 28, 2024 December 28, 2024, we used \$274.7 million \$348.5 million to repurchase shares of our Class A common stock pursuant to our common stock repurchase program, and an additional \$55.5 million \$56.1 million in shares of our Class A common stock were surrendered or withheld in satisfaction of withholding taxes in connection with the vesting of awards under our long-term stock incentive plans. On a comparative basis, during the six nine months ended September 30, 2023 December 30, 2023, we used \$175.0 million \$277.7 million to repurchase shares of our Class A common stock pursuant to our common stock repurchase program, and an additional \$50.7 million \$51.1 million in shares of our Class A common stock were surrendered or withheld for taxes.

Sources of Liquidity

Our primary sources of liquidity are the cash flows generated from our operations, our available cash and cash equivalents and short-term investments, availability under our credit and overdraft facilities and commercial paper program, and other available financing options.

During the six nine months ended September 28, 2024 December 28, 2024, we generated \$374.5 million \$1.113 billion of net cash flows from our operations. As of September 28, 2024 December 28, 2024, we had \$1.690 billion \$2.143 billion in cash, cash equivalents, and short-term investments, of which \$1.359 billion \$1.370 billion were held by our subsidiaries domiciled outside the U.S. We are not dependent on foreign cash to fund our domestic operations. Undistributed foreign earnings generated on or before December 31, 2017 that were subject to the one-time mandatory transition tax in connection with U.S. tax legislation commonly referred to as the Tax Cuts and Jobs Act (the "TCJA") are not considered to be permanently reinvested and may be repatriated to the U.S. in the future with minimal or no additional U.S. taxation. We intend to permanently reinvest undistributed foreign earnings generated after December 31, 2017 that were not subject to the one-time mandatory transition tax. However, if our plans change and we choose to repatriate post-2017 earnings to the U.S. in the future, we would be subject to applicable U.S. and foreign taxes.

We believe that the Global Credit Facility is adequately diversified with no undue concentration in any one financial institution. In particular, as of **September 28, 2024** **December 28, 2024**, there were seven financial institutions participating in the Global Credit Facility, with no one participant maintaining a maximum commitment percentage in excess of 20%. In accordance with the terms of the agreement, we have the ability to expand our borrowing availability under the Global Credit Facility to \$1.500 billion through the full term of the facility, subject to the agreement of one or more new or existing lenders under the facility to increase their commitments.

Borrowings under the Pan-Asia Credit Facilities and Japan Overdraft Facility (collectively, the "Pan-Asia Borrowing Facilities") are guaranteed by the parent company and are granted at the sole discretion of the participating banks (as described within Note 9 to the accompanying consolidated financial statements), subject to availability of the respective banks' funds and satisfaction of certain regulatory requirements. We have no reason to believe that the participating institutions will be unable to fulfill their obligations to provide financing in accordance with the terms of the Global Credit Facility and the Pan-Asia Borrowing Facilities in the event of our election to draw additional funds in the foreseeable future.

Our sources of liquidity are used to fund our ongoing cash requirements, including working capital requirements, global retail store and digital commerce expansion, construction and renovation of shop-within-shops, investment in infrastructure, including technology, acquisitions, payment of dividends, debt repayments, Class A common stock repurchases, settlement of contingent liabilities (including uncertain tax positions), and other corporate activities, including our restructuring actions. We believe that our existing sources of cash, the availability under our credit facilities, and our ability to access capital markets will be sufficient to support our operating, capital, and debt service requirements for the foreseeable future, the ongoing development of our businesses, and our plans for further business expansion. However, prolonged periods of adverse economic conditions or business disruptions in any of our key regions, or a combination thereof, such as those resulting from pandemic diseases and other catastrophic events, could impede our ability to pay our obligations as they become due or return value to our shareholders, as well as delay previously planned expenditures related to our operations.

See Note 9 to the accompanying consolidated financial statements and Note 11 of the Fiscal 2024 10-K for additional information relating to our credit facilities.

Supplier Finance Program

We support a voluntary supplier finance program which provides certain of our inventory suppliers the opportunity, at their sole discretion, to sell their receivables due from us (which are generally due within 90 days) to a participating financial institution in exchange for receipt of a discounted payment amount made earlier than the payment term stipulated between us and the supplier. Our vendor payment terms and amounts due are not impacted by a supplier's decision to participate in the program. We have not pledged any assets and do not provide guarantees under the supplier finance program. Our payment obligations outstanding under our supplier finance program were **\$215.5 million** **\$216.2 million** and **\$129.2 million** as of **September 28, 2024** **December 28, 2024** and March 30, 2024, respectively, and were recorded within accounts payable in the consolidated balance sheets.

Debt and Covenant Compliance

In August 2018, we completed a registered public debt offering and issued \$400 million aggregate principal amount of unsecured senior notes due September 15, 2025, which bear interest at a fixed rate of 3.750%, payable semi-annually (the "3.750% Senior Notes"). In June 2020, we completed another registered public debt offering and issued an additional \$500 million aggregate principal amount of unsecured senior notes that were due and repaid on June 15, 2022 with cash on hand, which bore interest at a fixed rate of 1.700%, payable semi-annually (the "1.700% Senior Notes"), and \$750 million aggregate principal amount of unsecured senior notes due June 15, 2030, which bear interest at a fixed rate of 2.950%, payable semi-annually (the "2.950% Senior Notes").

The indenture and supplemental indentures governing the 3.750% Senior Notes and 2.950% Senior Notes (as supplemented, the "Indenture") contain certain covenants that restrict our ability, subject to specified exceptions, to incur certain liens; enter into sale and leaseback transactions; consolidate or merge with another party; or sell, lease, or convey all or substantially all of our property or assets to another party. However, the Indenture does not contain any financial covenants.

We have a credit facility that provides for a \$750 million senior unsecured revolving line of credit through June 30, 2028, which may be used for working capital needs, capital expenditures, certain investments, general corporate purposes, and for funding of acquisitions, as well as used to support the issuance of letters of credit and the maintenance of

the Commercial Paper Program (the "Global Credit Facility"). Borrowings under the Global Credit Facility may be denominated in U.S. Dollars and certain other currencies, including Euros, Hong Kong Dollars, and Japanese Yen. We have the ability to expand the borrowing availability under the Global Credit Facility to \$1.500 billion, subject to the agreement of one or more new or existing lenders under the facility to increase their commitments. There are no mandatory reductions in borrowing ability throughout the term of the Global Credit Facility.

The Global Credit Facility contains a number of covenants, as described in Note 9 to the accompanying consolidated financial statements. As of **September 28, 2024** **December 28, 2024**, no Event of Default (as such term is defined pursuant to the Global Credit Facility) has occurred under our Global Credit Facility. The Pan-Asia Borrowing Facilities do not contain any financial covenants.

See Note 9 to the accompanying consolidated financial statements and Note 11 of the Fiscal 2024 10-K for additional information relating to our debt and covenant compliance.

Common Stock Repurchase Program

On February 2, 2022, our Board of Directors approved an expansion of our existing common stock repurchase program that allowed us to repurchase up to an additional \$1.500 billion of our Class A common stock, excluding related excise taxes. As of **September 28, 2024** **December 28, 2024**, the remaining availability under our Class A common stock repurchase program was approximately **\$502 million** **\$428 million**. Repurchases of shares of our Class A common stock are subject to overall business and market conditions.

See Note 13 to the accompanying consolidated financial statements for additional information relating to our Class A common stock repurchase program.

Dividends

We have generally maintained a regular quarterly cash dividend program on our common stock since 2003.

On May 16, 2024, our Board of Directors approved an increase to our quarterly cash dividend on our common stock from \$0.75 to \$0.825 per share.

We intend to continue to pay regular dividends on outstanding shares of our common stock. However, any decision to declare and pay dividends in the future will ultimately be made at the discretion of our Board of Directors and will depend on our results of operations, cash requirements, financial condition, and other factors that the Board of Directors may deem relevant, including economic and market conditions.

See Note 13 to the accompanying consolidated financial statements for additional information relating to our quarterly cash dividend program.

Material Cash Requirements

There have been no substantial changes to our material cash requirements as disclosed in our Fiscal 2024 10-K, other than those which occur in the ordinary course of business. Refer to the "Financial Condition and Liquidity — Contractual and Other Obligations" section of the MD&A in our Fiscal 2024 10-K for detailed disclosure of our material cash requirements as of March 30, 2024.

MARKET RISK MANAGEMENT

As discussed in Note 13 of the Fiscal 2024 10-K and Note 11 to the accompanying consolidated financial statements, we are exposed to a variety of levels and types of risks, including the impact of changes in currency exchange rates on foreign currency-denominated balances, certain anticipated cash flows of our international operations, and the value of reported net assets of our foreign operations, as well as changes in the fair value of our fixed-rate debt obligations relating to fluctuations in benchmark interest rates. Accordingly, in the normal course of business we assess such risks and, in accordance with our established policies and procedures, may use derivative financial instruments to manage and mitigate them. We do not use derivatives for speculative or trading purposes.

Given our use of derivative instruments, we are exposed to the risk that the counterparties to such contracts will fail to meet their contractual obligations. To mitigate such counterparty credit risk, it is our policy to only enter into contracts with carefully selected financial institutions based upon an evaluation of their credit ratings and certain other factors, adhering to established limits for credit exposure. Our established policies and procedures for mitigating credit risk include ongoing review and assessment of the creditworthiness of our counterparties. We also enter into master netting arrangements with counterparties, when possible, to further mitigate credit risk. As a result of the above considerations, we do not believe that we are exposed to undue concentration of counterparty risk with respect to our derivative contracts as of **September 28, 2024** **December 28, 2024**. However, we do have in aggregate **\$15.1 million** **\$62.0 million** of derivative instruments in net asset positions held across **three** **eight** creditworthy financial institutions.

Foreign Currency Risk Management

We manage our exposure to changes in foreign currency exchange rates using forward foreign currency exchange and cross-currency swap contracts. Refer to Note 11 to the accompanying consolidated financial statements for a summary of the notional amounts and fair values of our outstanding forward foreign currency exchange and cross-currency swap contracts, as well as the impact on earnings and other comprehensive income of such instruments as of **September 28, 2024** **December 28, 2024**.

Forward Foreign Currency Exchange Contracts

We enter into forward foreign currency exchange contracts to mitigate risk related to exchange rate fluctuations on inventory transactions made in an entity's non-functional currency, the settlement of foreign currency-denominated balances, and the translation of certain foreign operations' net assets into U.S. Dollars. As part of our overall strategy for managing the level of exposure to such exchange rate risk, relating primarily to the Euro, the Japanese Yen, the South Korean Won, the Australian Dollar, the Canadian Dollar, the British Pound Sterling, the Swiss Franc, and the Chinese Renminbi, we generally hedge a portion of our related exposures anticipated over the next twelve months using forward foreign currency exchange contracts with maturities of two months to one year to provide continuing coverage over the period of the respective exposure.

Our foreign exchange risk management activities are governed by established policies and procedures. These policies and procedures provide a framework that allows for the management of currency exposures while ensuring the activities are conducted within our established guidelines. Our policies include guidelines for the organizational structure of our risk management function and for internal controls over foreign exchange risk management activities, including, but not limited to, authorization levels, transaction limits, and credit quality controls, as well as various measurements for monitoring compliance. We monitor foreign exchange risk using different techniques, including periodic review of market values and performance of sensitivity analyses.

Cross-Currency Swap Contracts

We periodically designate pay-fixed rate, receive-fixed rate cross-currency swap contracts as hedges of our net investment in certain European subsidiaries. These contracts swap U.S. Dollar-denominated fixed interest rate payments based on the contract's notional amount and the fixed rate of interest payable on certain of our senior notes for Euro-denominated fixed interest rate payments, thereby economically converting a portion of our fixed-rate U.S. Dollar-denominated senior note obligations to fixed rate Euro-denominated obligations.

See Note 3 to the accompanying consolidated financial statements for further discussion of our foreign currency exposures and the types of derivative instruments used to hedge those exposures.

Investment Risk Management

As of September 28, 2024 December 28, 2024, we had cash and cash equivalents on-hand of \$1.355 billion \$1.940 billion, consisting of deposits in interest bearing accounts, investments in money market deposit accounts, and investments in time deposits with original maturities of 90 days or less. Our other significant investments included \$334.7 million \$203.0 million of short-term investments, consisting of investments in time deposits with original maturities greater than 90 days.

We actively monitor our exposure to changes in the fair value of our global investment portfolio in accordance with our established policies and procedures, which include monitoring both general and issuer-specific economic conditions, as discussed in Note 3 to the accompanying consolidated financial statements. Our investment objectives include capital preservation, maintaining adequate liquidity, diversification to minimize liquidity and credit risk, and achievement of maximum returns within the guidelines set forth in our investment policy. See Note 11 to the accompanying consolidated financial statements for further detail of the composition of our investment portfolio as of September 28, 2024 December 28, 2024.

CRITICAL ACCOUNTING POLICIES

Our significant accounting policies are described in Note 3 of the Fiscal 2024 10-K. Our estimates are often based on complex judgments, assessments of probability, and assumptions that management believes to be reasonable, but that are inherently uncertain and unpredictable. It is also possible that other professionals, applying reasonable judgment to the same set of facts and circumstances, could develop and support a range of alternative estimated amounts. For a complete discussion of our critical accounting policies, refer to the "Critical Accounting Policies" section of the MD&A in our Fiscal 2024 10-K.

There have been no significant changes in the application of our critical accounting policies since March 30, 2024.

Goodwill Impairment Assessment

We performed our annual goodwill assessment using a qualitative approach as of the beginning of the second quarter of Fiscal 2025. In performing the assessment, we identified and considered the significance of relevant key factors, events, and circumstances that affected the fair values and/or carrying amounts of our reporting units with allocated goodwill. These factors included external factors such as macroeconomic, industry, and market conditions, as well as entity-specific factors, such as the Company's actual and expected financial performance. Additionally, we also considered the results of our most recent quantitative goodwill impairment test, which was performed as of the beginning of the second quarter of Fiscal 2024, the results of which indicated that the fair values of these reporting units significantly exceeded their respective carrying values. Based on the results of the qualitative impairment assessment, we concluded that it is not more likely than not that the fair values of our reporting units are less than their respective carrying values and there were no reporting units at risk of impairment.
