(â€œWalmartâ€). As a result of this transaction, JD.com,Â Inc. (â€œJD.comâ€) has acquired all the shares of Dada held by Walmart and beneficially owned approximately 63.2% of the Companyâ€™s total ordinary shares outstanding. In addition, Ms.Â Christina Xiaojing Zhu, the president and chief executive officer of Walmart China, has resigned from the Companyâ€™s board of directors, effective immediately. Â Following the transaction, the Company expects to continue the mutually beneficial business collaboration with Walmart. Furthermore, the Company views the further investment by JD.com, the largest shareholder of the Company, as an indication of the unique role that the Company fulfills within JD.comâ€™s broader ecosystem, which also reflects JD.comâ€™s confidence in the Companyâ€™s growth and development over the long term.
