Televisa confirms that the Company did not operate its repurchase program; and that it is not aware that any of the members of its Board of Directors or any of its relevant executive officers participated in such trading. This communication is made at the request of the Mexican Stock Exchange, based on the provisions of article 106 of the Securities Market Law (Ley del Mercado de Valores) and article 50, second to last paragraph, of the General Provisions applicable to issuers of securities and to other participants of the stock market (Disposiciones de carâcter general aplicables a las emisoras de valores y a otros participantes del mercado de valores). About Televisa Grupo Televisa S.A.B. (âœTelevisaâ€) is a major telecommunications corporation which owns and operates one of the most significant cable companies as well as a leading direct-to-home satellite pay television system in Mexico. Televisaâ€™s cable business offers integrated services, including video, high-speed data and voice to residential and commercial customers as well as managed services to domestic and international carriers. Televisa owns Sky, a leading direct-to-home satellite pay television system and broadband provider in Mexico. Televisa holds a number of concessions by the Mexican government that authorizes it to broadcast programming over television stations for the signals of TelevisaUnivision, Inc. (âœTelevisaUnivisionâ€), and Televisaâ€™s cable and DTH systems. In addition, Televisa is the largest shareholder of TelevisaUnivision, a leading media company producing, creating, and distributing Spanish-speaking content through several broadcast channels in Mexico, the US and over 50 countries through television networks, cable operators and over-the-top or âœOTTâ€ services.
