Director Â On December 19, 2024, Yehoshua (Shuki) Nir submitted his resignation from the Board of Directors (the
â€œBoardâ€), and all committees of the Board, of Kornit Digital Ltd (the â€œCompanyâ€), effective as of January 1,
2025. Â Mr. Nirâ€™s decision to resign from the Board follows upon his appointment as the new CEO of SolarEdge, as
his new responsibilities in that capacity will prevent him from dedicating sufficient time to actively serving on the
Board. The resignation did not relate to any dispute or disagreement with the Company or the Board. Â Effective upon
Mr. Nirâ€™s resignation, the Board will replace him on the Board committees on which he had served. Accordingly,
Gabi Seligsohn will replace Mr. Nir as a member of the compensation committee of the Board, alongside Stephen Nigro
and Dov Ofer, and Mr. Ofer will assume Mr. Nirâ€™s role as chairman of the compensation committee. On the audit
committee of the Board, Stephen Nigro will replace Mr. Nir, thereby giving that committee three independent directors
with the requisite financial sophistication, as required under the Nasdaq Listing Rules and Rule 10A-3 under the
